**AN ORDINANCE OF THE CITY OF CARRIZO SPRINGS
AMENDING ORDINANCE NO. 765 "EXHIBIT A" PERMITS &
FEE SCHEDULE DEMOLITION PERMIT (STRUCTURE
MUST BE DEMOLISHED WITHIN 30 DAYS)**

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF
CARRIZO SPRINGS, TEXAS THAT:**

SECTION 1: The Permits and Fee Schedule in attached "Exhibit A" is incorporated for all purposes as if fully set forth herein.

SECTION 2: The Permits and Fee Schedule in attached "Exhibit A" is to be charged and collected by the City of Carrizo Springs from all customers for residential, commercial, construction and planning and zoning purposes and is hereby adopted and established as set forth in Exhibit A.

SECTION 3: The provisions of all other ordinances not in conflict with this Ordinance shall remain in full force and effect.

0 to 1,000 square feet	\$90
Each additional 1,000 square feet or portion thereof)	\$25
Remodeling (Repair / Replacement)	\$65
Roof Repair (Includes two inspections)	\$105
Demolition	\$65
(Structure must be demolished within 30 days)	
Structure to be demolished must be tested for asbestos and lead. Copies of the asbestos and lead test results are required to be submitted with the application for demolition.	
Moving (Relocation)	\$65
Foundation / Slab (Miscellaneous)	\$60
Additional Inspection Fees	\$25
If project requires Plumbing Inspections (including Water Heater Inspections) said inspections will cost an additional \$175.00. This applies to Residential and Commercial Projects.
