#### **ORDINANCE NO. 798**

AN ORDINANCE AMENDING SECTION (1) ONE OF ORDINANCE NO. 675 ENTITLED "TIPPING FEES AT LANDFILL; AND CHARGES" APPROVING TIPPING FEE OF VEHICLE TIRES FOR DISPOSAL AT THE CITY OF CARRIZO SPRINGS' LANDFILL

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CARRIZO SPRINGS, TEXAS, THAT:

**SECTION 1:** Section entitled Tipping fees at landfill; Proof of Residency and Charges is hereby amended to read as follows:

City Residency and Charges is hereby amended to read as follows:

### FREE QUARTERLY ENTRANCE TO LANDFILL

- (A) No charges shall be imposed to City residential customers for disposing domestic items such as brush, limbs, leaves, furniture, and appliances during the following time periods:
  - (1) March of each year on the last five (5) working days,
  - (2) June of each year on the last five (5) working days,
  - (3) September of each year on the last five (5) days,
  - (4) December of each year on the last five (5) days.
- (B) The above time periods shall not apply to demolition and/or construction materials.

#### PROOF OF CITY RESIDENCE

(C) City Residential Customer shall provide proof of residency in Carrizo Springs to gate keeper by presenting their driver's licenses, and a copy of the most recent utility bill to determine whether a person or entity is a landfill user.

All fees per load will be calculated pursuant to the following schedule and will be subject to a minimum fee of \$5.00 per load between 0 - 200 pounds. Commercial private business rates will be two (2) times the regular rate.
