

ORDINANCE NO. 200AN ORDINANCE TO REPEAL AND RECREATE SECTION 7.02
OF THE VILLAGE OF NASHOTAH VILLAGE CODE
RELATED SPEED LIMITS AND OFFICIAL TRAFFIC SIGNS

The Village Board of the Village of Nashotah, Waukesha County, Wisconsin, DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: Chapter 7 of the Village of Nashotah Village Code entitled "Traffic Code," Section 7.02 entitled "Speed Limits," is hereby repealed and recreated with the heading "Official Traffic Map," as follows:

7.02 OFFICIAL TRAFFIC MAP.

(A) Official Traffic Map Established. The Official Traffic Map designating the location of all authorized stop signs, yield signs, signals, speed limits, no parking zones, restricted parking zones, and other traffic restrictions and limitations contained in this code within the Village limits is hereby adopted. Said map accompanies and is hereby made part of this ordinance.

(B) Violations Prohibited. When official traffic control devices giving notice of the restrictions, prohibitions and limitations shown on the Official Traffic Map are erected and maintained in accordance with the provisions of this section a violation of the restriction, prohibition or limitation shown on the Official Traffic Map shall be a violation of the provisions of this code.

(C) Map to be Maintained. A copy of the Official Traffic Map shall be maintained and displayed in the office of the Village Clerk.

(D) Additions to Map. The Village Board may from time to time make additions to or deletion from the Official Traffic Map by resolution and the Village Engineer or designated representative shall keep such Official Traffic Map current.

(E) The Village Director of Public Works or designee shall procure, erect and maintain appropriate standard traffic signs, signals, and markings conforming to the rules of the State Department of transportation giving notice of the provisions of s. 346.57, 346.58, and 346.59, Wis. Stats., and s. 7.04 of this chapter. Signs shall be erected in such locations and manner as to give adequate warning to users of the street, alley or highway in question.

SECTION 2: SEVERABILITY.

The several sections of this ordinance are declared to be severable. If any section or portion thereof shall be declared by a court of competent jurisdiction to be invalid, unlawful or unenforceable, such decision shall apply only to the specific section or portion thereof directly

specified in the decision, and shall not affect the validity of any other provisions, sections, or portions thereof of the ordinance. The remainder of the ordinance shall remain in full force and effect. Any other ordinances whose terms are in conflict with the provisions of this ordinance are hereby repealed as to those terms that conflict.

SECTION 3: EFFECTIVE DATE.

This ordinance shall take effect immediately upon passage and posting or publication as provided by law.
