

ORDINANCE NO. 2021-01

**AN ORDINANCE OF THE COMMON COUNCIL OF THE CITY OF
LAKE STATION, INDIANA AMENDING CHAPTER 7, ARTICLE 2, SECTION 7-99.
OF THE CITY OF LAKE STATION CODE OF ORDINANCES**

WHEREAS, Chapter 7, Article 2, Section 7-99(o) of the Code of Ordinances of the City of Lake Station establishes license application, testing, fees and special requirements imposed upon general contractors and specialty contractors; and

WHEREAS, Chapter 7, Article 2, Section 7-99(i) establishes liability and property damage insurance requirements of general contractors and specialty contractors prior to the issuance of a license and/or registration; and

WHEREAS, the Common Council now desires to amend and/or delete certain provisions of Chapter 7, Article 2, Section 7-99(o) and Section 7-99(i) as it relates to fees to be charged to contractors or specialty contractors regarding licenses and certificates of registration, renewals and liability and property damage insurance requirements of each applicant.

NOW, THEREFORE, LET IT BE ORDAINED by the Common Council of the City of Lake Station, Lake County, Indiana, as follows:

That Chapter 7, Article 2, Section 7-99(o) of the City of Lake Station Code of Ordinances shall now read as follows:

- (o) The fees to be charged by and paid to the Board by licensees or registrants for all licenses and certificates of registration and renewals thereof shall be as follows:
 - (1) A fee of fifteen dollars (\$15.00) shall accompany an application for examination as a contractor or as a registrant.
 - (2) An additional fee of one hundred ten dollars (\$110.00) shall be required for the initial issuance of the license of a general contractor, upon successful passage of the examination and registration.
 - (3) A fee of sixty dollars (\$60.00) shall be required for every annual renewal of a license or registration.
 - (4) Each applicant shall submit a certificate of insurance pursuant to Section 7-99(i) in the following minimum amounts:

General Contractor....\$1,000,000.00

Specialty Contractor...\$1,000,000.00

That Chapter 7, Article 2, Section 7-99(i) of the City of Lake Station Code of Ordinances shall now read as follows:

- (i) Liability and property damage insurance in the amount of one million dollars (\$1,000,000.00) shall be required of each contractor and specialty contractor. A certificate of insurance or copy of the insurance policy including the policy number shall be filed with the Board by the licensed or registered contractor or specialty contractor as herein provided prior to the issuance of such license or certificate of registration.
