**ORDINANCE 2025-02**

1 AN ORDINANCE BY MAYOR ANGELYNE BUTLER AND COUNCILMEMBERS  
2 KIMBERLY JAMES, DABOUZE ANTOINE, HECTOR GUTIERREZ, LATRESA  
3 AKINS-WELLS, AND ALLAN MEARS OF THE CITY OF FOREST PARK, GEORGIA  
4 TO AMEND THE CITY’S CODE OF ORDINANCES BY ADOPTING SECTION 8-8-  
5 142 (TREE BANK) WITHIN ARTICLE E (TREE PROTECTION), CHAPTER 8  
6 (ZONING), TITLE 8 (PLANNING AND DEVELOPMENT); TO PROVIDE AN  
7 ADOPTION DATE; TO PROVIDE AN EFFECTIVE DATE; AND FOR OTHER  
8 LAWFUL PURPOSES.

9 **WHEREAS**, the duly elected governing authority of the City of Forest Park, Georgia  
10 (“City”) is the Mayor and Council thereof; and

11 **WHEREAS**, these changes adhere to all zoning procedures as well as notice and hearing  
12 requirements pursuant to O.C.G.A. § 36-66-1, *et seq.*; and

13 **WHEREAS**, the City Council desires to establish a tree bank fund to balance  
14 development with environmental sustainability, ensuring that trees are planted where  
15 possible while allowing flexibility through tree banking contributions where necessary; and

16 **WHEREAS**, the amendments contained herein would benefit the health, safety, morals,  
17 and welfare of the citizens of the City.

18 **BE IT AND IT IS HEREBY ORDAINED** by the Mayor and Council of the City of  
19 Forest Park, Georgia, and by the authority thereof:

20 **Section 1.** Title 8 (“Planning and Development”), Chapter 8 (“Zoning”), Article E (“Tree  
21 Protection”) in the City’s Code of Ordinances is hereby amended by adopting Section 8-8-

22 142 (“Tree Banking”) to be read and codified as set forth in **Exhibit A** attached hereto and  
23 incorporated herein.

24 **Section 2.** The preamble of this Ordinance shall be considered to be and is hereby  
25 incorporated by reference as if fully set out herein.

26 **Section 3.** This Ordinance shall be codified in a manner consistent with the laws of the  
27 State of Georgia and the City of Forest Park.

28 **Section 4.** (a) It is hereby declared to be the intention of the Mayor and Council that all  
29 sections, paragraphs, sentences, clauses, and phrases of this Ordinance are or were, upon  
30 their enactment, believed by the Mayor and Council to be fully valid, enforceable, and  
31 constitutional.

32 (b) It is hereby declared to be the intention of the Mayor and Council that, to the greatest  
33 extent allowed by law, each and every section, paragraph, sentence, clause, or phrase of  
34 this Ordinance is severable from every other section, paragraph, sentence, clause, or phrase  
35 of this Ordinance. It is hereby further declared to be the intention of the Mayor and Council  
36 that, to the greatest extent allowed by law, no section, paragraph, sentence, clause, or phrase  
37 of this Ordinance is mutually dependent upon any other section, paragraph, sentence,  
38 clause, or phrase of this Ordinance.

39 (c) In the event that any phrase, clause, sentence, paragraph or section of this Ordinance  
40 shall, for any reason whatsoever, be declared invalid, unconstitutional or otherwise  
41 unenforceable by the valid judgment or decree of any court of competent jurisdiction, it is  
42 the express intent of the Mayor and Council that such invalidity, unconstitutionality or  
43 unenforceability shall, to the greatest extent allowed by law, not render invalid,  
44 unconstitutional or otherwise unenforceable any of the remaining phrases, clauses,

45 sentences, paragraphs or sections of the Ordinance and that, to the greatest extent allowed  
46 by law, all remaining phrases, clauses, sentences, paragraphs and sections of the Ordinance  
47 shall remain valid, constitutional, enforceable, and of full force and effect.

48 **Section 5.** All ordinances and parts of ordinances in conflict herewith are hereby  
49 expressly repealed.

50 **Section 6.** This ordinance shall become effective immediately upon its adoption by the  
51 Mayor and City Council of the City of Forest Park as provided in the City Charter.

52 **Section 7.** The City Clerk, with the concurrence of the City Attorney, authorized to  
53 correct any scrivener's errors found in this Ordinance, including any exhibits, as enacted.



61 Section 8-8-142. - Tree Banking.

62 (a) *Tree Bank Fund.* There is hereby established a Tree Bank Fund (the “Fund”) for the City  
63 of Forest Park, Georgia, which shall be used to acquire, plant, and maintain trees on public  
64 properties or in areas designated by the City, including parks, green spaces, and rights-of-  
65 way.

66 (1) *Mission of the Fund.* The Fund aims to balance development with environmental  
67 sustainability, ensuring that trees are planted where possible while allowing  
68 flexibility through tree banking contributions where necessary.

69 (2) *Tree Bank Fund Contributions.* The Fund shall receive contributions from (i) fees  
70 paid by developers in lieu of planting or replacing trees on development sites as part  
71 of land use or building permit requirements; (ii) grants, donations, or other  
72 contributions from individuals, businesses, or organizations for tree-related activities;  
73 and (iii) city budget allocations, if applicable, for tree planting and environmental  
74 sustainability projects.

75 (3) *Administration of the Tree Bank Fund.* The Fund shall be administered by the City’s  
76 Department of Public Works or another designated city agency. The designated  
77 agency shall have the authority to use the Fund for the purposes set forth in this  
78 ordinance, including paying for tree planting, maintenance, and associated costs, as  
79 well as other tree-related projects.

80 (b) *Tree Banking Procedure and Process.* In the initial phase of development, City Planning  
81 and Community Development staff will review the project for tree banking during key

82 stages of the development process, particularly during the predevelopment application  
83 meeting in which staff will review site plans or development permit application prior to  
84 submission to decide if applicant will be required to plant trees per landscaping standards  
85 in section 8-8-89 or donate to tree fund. Applicants shall be notified during the review  
86 process about the specific requirements for tree planting or the donation to the Fund. All  
87 decisions shall be based on compliance with local tree protection laws, site feasibility, and  
88 project design. Staff shall monitor compliance during the construction phase to ensure that  
89 trees are planted as required, or Fund donations are made as agreed upon.

90 (1) The city review will focus on the following:

- 91 a. A review of existing trees on the site will occur to identify trees for preservation,  
92 removal, and new planting.
- 93 b. An assessment if the project complies with the landscaping standards in section  
94 8-8-89.
- 95 c. An evaluation of the feasibility of planting trees on-site given project  
96 constraints (i.e., space limitations, soil conditions, environment, etc.) If  
97 adequate space for tree planting cannot be provided, staff may consider  
98 alternative options such as donating to the tree fund or contributing to other  
99 environmental sustainability efforts.
- 100 d. In some cases, a combination of on-site tree planting and tree fund contributions  
101 may be required. This hybrid approach is typically used when there is limited  
102 space on-site, but planting some trees is still possible.

103 (2) Circumstances for city review will be based on the following:

- 104 a. *Residential Development.* For both new homes and multi-family  
105 developments, tree planting or contributions to the tree fund will be required  
106 based on the number of units and the size of the property.
- 107 b. *Commercial and Mixed-Use Development.* Projects such as office  
108 buildings, retail developments, or mixed-use spaces will also undergo  
109 review to determine if adequate space is available for tree planting or if a  
110 tree fund donation is necessary.

111 c. *Redevelopment Projects.* Projects involving the renovation or expansion of  
112 existing buildings may have different criteria depending on the extent of  
113 land alteration and available space for new trees.

114 d. *Public Projects.* Government-led initiatives will follow the same criteria but  
115 may also be evaluated for opportunities to enhance public green spaces with  
116 tree planting or donations.

117 (c) *Fees in lieu of tree planting.* When a development project or land-disturbing activity  
118 results in the removal of trees, and the developer is unable to replace the removed trees  
119 on-site due to space limitations or other reasons, the developer may pay a fee into the  
120 Fund. Fees paid into the Fund shall be used exclusively for the planting, establishment,  
121 maintenance, and care of trees within the City's public spaces, rights-of-way, or other  
122 designated areas as determined by the City Council.

123 (1) *Fee Calculation.* The amount of the fee shall be determined according to the  
124 following criteria: (i) the number, size, and type of trees removed; (ii) the cost of  
125 planting and maintaining a comparable number of trees in public spaces or other  
126 locations is determined by the city; and (iii) landscaping standards within section  
127 8-8-89 and overall environmental impact determined by the City and other  
128 applicable regulations. Fees may be adjusted annually to reflect inflation or  
129 changes in the costs of planting and maintaining trees.

130 (d) *Tree planting and maintenance.*

131 (1) *Selection of Planting Sites.* The City shall identify and prioritize areas for tree  
132 planting, with a focus on (i) public parks and recreational areas; (ii) streets, rights-  
133 of-way, and medians; (iii) areas impacted by development or tree loss; and (iv)  
134 private property along the right-of-way. Any developer who plans to plant street  
135 trees, will follow standards as outlined within the Sidewalk and street tree  
136 standards in section 8-8-88(d).

137 (2) *Species Selection.* The City shall select tree species for planting based on the local  
138 climate, soil conditions, and aesthetic considerations, and prioritize native species  
139 or those that provide significant ecological or environmental benefits.

140 (3) *Maintenance.* Trees planted through the Fund shall be maintained by the City or  
141 its designated contractors. Maintenance shall include watering, pruning, pest  
142 management, and other necessary activities to ensure the long-term health and  
143 survival of the trees.

144 (4) *Monitoring and Reporting.* The City shall maintain records of tree planting  
145 activities funded through the Tree Bank and report annually on the status of the  
146 Fund, including the number of trees planted, locations, and any challenges  
147 encountered in the planting and maintenance process.

148 (e) *Enforcement and Penalties.*

149 (1) *Compliance.* Developers, contractors, and property owners must comply with the  
150 tree preservation and replacement requirements set forth in the City's Planning  
151 and Development Ordinance. Failure to do so may result in the assessment of  
152 additional fees or penalties.

153 (2) *Penalty for Non-Payment of Fees.* Failure to pay the required tree bank fee in lieu  
154 of planting may be subject to penalties as determined by section 1-1-8.
