## A BILL TO BE ENTITLED AN ACT

- 1 To amend an Act providing for a new charter for the City of Sandersville, approved
- 2 March 28, 1990 (Ga. L. 1990, p. 4823), as amended, particularly by an Act approved April
- 3 29, 2014 (Ga. L. 2014, p. 4290), so as to change the provisions regarding election of
- 4 members of the city council; to provide for related matters; to repeal conflicting laws; and
- 5 for other purposes.

## BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

7 SECTION 1. 8 An Act providing for a new charter for the City of Sandersville, approved March 28, 1990 9 (Ga. L. 1990, p. 4823), as amended, particularly by an Act approved April 29, 2014 (Ga. L. 10 2014, p. 4290), is amended by revising subsection (f) of Section 2.11 as follows: 11 "(f)(1) For the purposes of electing members of the city council, the territory of the City 12 of Sandersville is divided into four posts, which shall be and correspond to those four 13 numbered districts described in and attached to and made a part of this Act and further 14 identified as 'Plan Name: sandersville-2013 Plan Type: Local Administrator: Sandersville 15 User: bak'. 16 (2) When used in such attachment, the term 'VTD' (voting tabulation district) shall mean 17 and describe the same geographical boundaries as provided in the report of the Bureau 18 of the Census for the United States decennial census of 2010 for the State of Georgia. 19 (3) The separate numeric designations in a district description which are underneath a 20 VTD heading shall mean and describe individual Blocks within a VTD as provided in the 21 report of the Bureau of the Census for the United States decennial census of 2010 for the 22 State of Georgia. Any part of the City of Sandersville which is not included in any such 23 district described in that attachment shall be included within that district contiguous to 24 such part which contains the least population according to the United States decennial 25 census of 2010 for the State of Georgia.

(4) Any part of the City of Sandersville which is described in that attachment as being in a particular district shall nevertheless not be included within such district if such part is not contiguous to such district. Such noncontiguous part shall instead be included within that district contiguous to such part which contains the least population according to the United States decennial census of 2010 for the State of Georgia.
(5) Except as otherwise provided in the description of any council district, whenever the description of such district refers to a named city, it shall mean the geographical boundaries of that city as shown on the census map for the United States decennial census of 2010 for the State of Georgia."

It is the purpose of this Act to reapportion the districts from which members of the city 36 37 council for the City of Sandersville are to be elected in subsequent municipal elections, and this Act results from changes in population based on the United States decennial census of 38 39 2010. It is not the intention of the General Assembly to affect the membership of current 40 members of the council, their terms of office, or the manner in which their successors shall 41 be elected, and such matters shall remain as provided by law on the effective date of this Act 42 until otherwise amended by law, except to the extent of reapportioning the districts 43 represented by such members.

44 SECTION 3.

45 All laws and parts of laws in conflict with this Act are repealed.

## **DESCRIPTION OF VOTING DISTRICTS**

1)

Post 1 Beginning at a point where the City of Sandersville city limits intersects Georgia Route 242 also known as Riddleville Road with said beginning point being on the center line of Georgia State Route 242 also known as Riddleville Road and proceeding in a northwesterly direction down the center line of the Riddleville Road until it intersects with Georgia Route 15 also known as Harris Street then proceeding in a northerly direction down the center line of Harris Street until it connects with Gilmore Street. Proceed in an easterly direction following the center line of Gilmore Street from Harris Street ending at Smith Street proceeding in a northerly direction along the center line of Smith Street until you reach Hines Street. At this point, proceed in an easterly direction along the center line of Hines Street until it connects with the Sandersville Railroad. Proceed in a northerly direction along the center line of the Sandersville Railroad until you connect with Georgia Route 24 also known as East McCarty Street. Proceed in an easterly direction along the center line of East McCarty Street also known as Georgia State Route 24 until reaching the Sandersville city limits and the proceeding in a southeasterly direction along the Sandersville city limits until reaching the point of beginning.

2)

POST 2 Beginning at a point where the City of Sandersville city limits intersects Georgia Route 242 also known as Riddleville Road with said beginning point being on the center line of Georgia Route 242 and continues northwesterly along the center line of Riddleville Road to Georgia Route 15 also known as Harris Street. Proceed to Harris Street continuing along the center line northwesterly to Jernigan Street then westerly along the center line of Jernigan Street to Warthen Street and southerly along the center line of Warthen Street to West Haynes Street. Turn in an easterly direction on West Haynes Street along the center line until reaching Brookins Street turning then southerly along the center line of Brookins Street to West Church Street also known as State Route 242 then along the center line of West Church Street in a westerly direction to Beck Boulevard. Proceed from Beck Boulevard along the center line of the road in a southerly direction to Kaolin Road and proceeding in a southwesterly direction along the center line of Kaolin Road until you intersect with Saffold Road. Continue from Saffold Road in a southeasterly direction along the centerline until reaching the Sandersville city limits. Turning in a southeasterly direction continue until reaching the point of beginning.

3)

<u>POST 3</u> Beginning at a point where the Sandersville city limits intersects Saffold Road with said beginning point being on the center line of Saffold Road and proceeding along the center line northwesterly intersecting with Kaolin Road. Proceeding northeasterly on Kaolin Road along the center line to Beck Boulevard and turning in a northwesterly direction following the center line proceed to West Church Street also known as State Route 242. At West Church Street turn in an easterly direction and proceed along the center line until reaching Brookins Street. Turn in a northerly direction at Brookins Street and proceed along the center line to West Haynes Street then turning in a westerly direction proceed along the center line to Warthen Street. From

Warthen Street proceed along the center line to Jernigan Street and follow the center line of Jernigan Street in an easterly direction until reaching GA Route 15 also known as Harris Street. Follow Harris Street in a southerly direction along the center line until reaching Gilmore Street. At Gilmore Street proceed in an easterly direction along the center line until intersecting with Smith Street. At Smith Street travel in a northerly direction along the center line until reaching Hines Street and then turning in an easterly direction and following the center line of Hines Street continue until reaching the Sandersville Railroad. Follow the center line of the Sandersville Railroad until reaching GA Route 15 also known as Sparta Road. Proceed along the center line of Sparta Road in a southerly direction to Washington Avenue and then along the center line in a southerly direction to East McCarty Street. From East McCarty Street proceed in a northwesterly direction along the center line as East McCarty Street becomes West McCarty Street and then Linton Road. Proceed until Linton Road intersects with the Fall Line Freeway also known as State Route 24. From the Fall Line Freeway continue in a northeasterly direction along the center line until reaching Transylvania Drive. At the center line of Transylvania Drive turn in a northwesterly direction and continue along the Sandersville city limits until reaching the point of beginning.

4)

POST 4 Beginning at the intersection of the city limits line of the City of Sandersville and East McCarty Street also known as GA State Route 24 with said beginning point being on the center line of GA State Route 24 and proceeding in a westerly direction until reaching the Sandersville Railroad. Proceed along the center line of the Sandersville Railroad in a northerly direction until reaching Washington Avenue and then turn in a southwesterly direction and continue along the center line until reaching East McCarty Street. Turn in a westerly direction on East McCarty Street and continue along the center line as the roads turn from East McCarty Street to West McCarty Street to Linton Road. Proceeding northerly on Linton Road continue along the center line until intersecting with GA State Route 24 also known as the Fall Line Freeway. Turning northeasterly from the center line of the Fall Line Freeway continue along the center line until reaching Transylvania Drive. At the center line of Transylvania Drive continue along the Sandersville city limits until reaching the point of beginning.

5)

POST 5 (Mayor Pro-Tem) Post Five shall incorporate the entire Sandersville city limits.

6)

<u>POST 6 (Mayor)</u> Post Six serves at large and this post incorporates the entire Sandersville city limits.
