ORDINANCE 2013-13

AN ORDINANCE OF THE CITY OF BUNNELL, FLORIDA ANNEXING APPROXIMATELY ± 10.43 **ACRES** PROPERTY LOCATED NEAR AND ALONG COUNTY ROAD 75 AND CONTIGUOUS TO THE CITY OF BUNNELL; REDEFINING BOUNDARIES OF THE CITY OF BUNNELL TO INCLUDE SAID PROPERTY; DIRECTING THE CITY CLERK TO FILE THE ORDINANCE WITH THE CLERK OF CIRCUIT COURT, WITH THE ADMINISTRATIVE OFFICER OF FLAGLER COUNTY AND WITH THE DEPARTMENT OF STATE; PROVIDING FOR CONFLICTING **ORDINANCES: PROVIDING** SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the petitioners, Roger Thompson and Caroly Thompson, are the owners of the real property described herein, containing ±10.43 acres; and

WHEREAS, the City Commission of the City of Bunnell has determined that all of the property which is proposed to be annexed into the City of Bunnell is within an unincorporated area of Flagler County, is contiguous to the City of Bunnell, and is reasonably compact; and

WHEREAS, The City Clerk has published the Notice of Annexation required by Section 171.044(2), Florida Statutes, at least once per week for two (2) consecutive weeks in a newspaper of general circulation in the City of Bunnell.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF BUNNELL, FLORIDA:

Section 1. Annexation.

The City Commission of the City of Bunnell, based on the above findings, hereby annexes into the City of Bunnell by voluntary petition property legally described in Exhibit "A", and depicted on the map in Exhibit "B", both attached hereto and made a part hereof.

Section 2. Municipal Boundary.

The City of Bunnell municipal boundary shall hereby be amended to incorporate the above described parcels of property.

Section 3. Filing of Ordinance.

Within seven (7) days of the adoption of this Ordinance, the City Clerk shall file a copy of said Ordinance with the Clerk of the Court, with the Chief Administrative Officer of Flagler County, and with the Department of State.

Section 4. Conflicts.

That all Ordinances made in conflict with this Ordinance are hereby repealed.

<u>Section 5. Severability.</u>
If any section, subsection, sentence, clause, phrase, or portion of this Ordinance, or application hereof, is for any reason held invalid or unconstitutional by any court, such portion or application shall be deemed a separate, distinct, and independent provision, and such holding shall not affect the validity of the remaining portions or application hereof.

<u>Section 6. Effective Date.</u>
This Ordinance shall become effective immediately upon its adoption.
