ORDINANCE NO. 24-14

An Ordinance To Amend Darlington County Code Of Ordinances, Chapter 2 (Administration), Article II. (County Council), Section 2-31 (Compensation Of Council Members And Officers), To Increase The Compensation Of Council Members And Officers And Establish The Effective Date Of This Ordinance

WHEREAS, the current compensation paid to the Darlington County Council is \$13,000 per year for members, \$13,000 per year for the vice chairman, and \$14,000 per year for the chairman; and

WHEREAS, the last increase in the compensation paid to members was effective January 1, 2019; and

WHEREAS, the 1976 S.C. Code of Laws, Section 4-9-100 establishes the requirements for adjusting the compensation paid to Council members.

NOW, THEREFORE, BE IT ORDAINED, by the governing body of the County of Darlington, South Carolina, the Darlington County Council, that

SECTION I.

Darlington County Code of Ordinances, Chapter 2 (Administration), Article II. (County Council), Section 2-31(a) which currently reads:

Sec. 2-31. Compensation of councilmembers and officers.

(a) *Established.* The compensation paid to members and officers of county council shall be as follows:

- (1) Members, \$13,000.00 per year;
- (2) Vice-chairman, \$13,000.00 per year;
- (3) Chairman, \$14,000.00 per year.

be amended to read as follows:

Sec. 2-31. Compensation of councilmembers and officers.

(a) *Established.* The compensation paid to members and officers of county council shall be as follows:

- (1) Members, \$13,792.00 per year;
- (2) Vice-chairman, \$13,792.00 per year;
- (3) Chairman, \$14,853.00 per year.


SECTION II.

The effective date of this ordinance shall be **January 1, 2025**
