

CITY OF HUEYTOWN

ORDINANCE NO. 21-0824-2

AN ORDINANCE TO AMEND SECTION 18-41 ENTITLED "LICENSE SCHEDULE" OF ARTICLE III ENTITLED "LICENSE SCHEDULE" OF CHAPTER 18 ENTITLED "BUSINESSES AND BUSINESS REGULATIONS" OF THE CODE OF ORDINANCES OF THE CITY OF HUEYTOWN, ALABAMA, AND TO PROVIDE FOR THE EFFECTIVE DATE THEREOF.

BE IT ORDAINED by the City Council of the City of Hueytown, Alabama, at a regular meeting, duly assembled, a quorum being present, as follows:

Section 1. That Section 18-41 entitled "License Schedule" of Article III entitled "License Schedule" of Chapter 18 entitled "Businesses and Business Regulations" of the Code of Ordinances of the City of Hueytown, Alabama, previously adopted by the City Council, is hereby amended as follows:

- a. The last two (2) sentences of Subsection (F) entitled "Number of workers in the city" of Subsection (w) entitled "License Fee Schedules (Fee Schedule for Ordinance 07-0814-1 as adopted in Ordinance 05-0628-1)" of Section 18-41 entitled "License Schedule" of Article III entitled "License Schedule" of Chapter 18 entitled "Businesses and Business Regulations of the Code of Ordinances of the City of Hueytown, Alabama are deleted in their entirety and the following are substituted in their place:

"HVAC contractor must supply a copy of state master card

Plumbing/gas-fitting contractor must supply a copy of state master card"

- b. Subsection (v) entitled "License Classification Codes" of Section 18-41 entitled "License Schedule" of Article III entitled "License Schedule" of Chapter 18 entitled "Businesses and Business Regulations of the Code of Ordinances of the City of Hueytown, Alabama, is supplemented and amended to add the following classification codes:

493120	Refrigerated Warehousing	BL

- c. Subsection (w) entitled "License Fee Schedules (Fee Schedule for Ordinance 07-0814-1 as adopted in Ordinance 05-0628-1)" of Section 18-41 entitled "License Schedule" of Article III entitled "License Schedule" of Chapter 18 entitled "Businesses and Business Regulations of the Code of Ordinances of the City of Hueytown, Alabama is supplemented and amended to add the following license schedule BL entitled "Warehouses":

Up to 5,000 square feet of floor space \$100.00
5,001 to 100,000 square feet of floor space \$120.00
Over 100,000\$120.00 plus
0.005 per square foot
over 100,001

- d. Subsection (w) entitled "License Fee Schedules (Fee Schedule for Ordinance 07-0814-1 as adopted in Ordinance 05-0628-1)" of Section 18-41 entitled "License Schedule" of Article III entitled "License

Schedule" of Chapter 18 entitled "Businesses and Business Regulations of the Code of Ordinances of the City of Hueytown, Alabama is amended to delete NAICS Code 713910 entitled "Country Club, Golf Course" in its entirety.

Section 2. That if any part, provision, or section of this ordinance is declared to be unconstitutional or invalid by any court of competent jurisdiction, all other parts, provisions or sections of this ordinance not thereby affected shall remain in full force and effect.

Section 3. That all other provisions of Chapter 18 of the Code of Ordinances of the City of Hueytown are to remain in full force and effect and shall not be affected by this amendment.

Section 4. This Ordinance shall become immediately effective upon its adoption by the City Council and approval by the Mayor or its otherwise becoming law.
