

**ORDINANCE 2020-07**

**AN ORDINANCE OF THE CITY OF INGLESIDE, TEXAS, NAMING A STREET  
"BENNIE DIEGEL AVENUE."**

**WHEREAS**, the City Code of Ordinances, Chapter 50 - STREETS, SIDEWALKS AND OTHER PUBLIC PLACES, ARTICLE II.- STREETS, DIVISION 2. - NAMES, Sec. 50-41, - Naming procedure, provides a process for the naming of streets in the city of Ingleside.; and,

**WHEREAS**, a roadway exists in Live Oak Park that is currently unnamed; and,

**WHEREAS**, Benjamin "Bennie" Walter Diegel was a pillar in the Ingleside community through his volunteer work with the Ingleside School District, the City of Ingleside City Council, and his commitment to youth sports for Ingleside children; and,

**WHEREAS**, Mr. Diegel passed away on November 25, 2019; and,

**WHEREAS**, the City Council wishes to honor Mr. Diegel's devotion to the community by naming a roadway located at Live Oak Park "Bennie Diegel Avenue" (See Attachment "A"); and,

**WHEREAS**, the unnamed roadway begins at the southernmost tip of Parkview Place and runs approximately 1,000 feet in a westerly direction; and,

**WHEREAS**, the City Council from time to time may determine that naming certain physical features of the City of Ingleside after individuals, events, or businesses will provide a source of pride and community recognition; and

**WHEREAS**, Bennie Diegel Avenue is not in conflict with the public interests and welfare; and

**WHEREAS**, the change of such street name is warranted.

**NOW THEREFORE: BE IT ORDAINED BY THE INGLESIDE CITY COUNCIL,  
INGLESIDE, TEXAS, THAT:**

**Section 1:** That the matter and facts recited in the preamble hereof are found and determined to be true and correct.

**Section 2:** The unnamed roadway located in Live Oak Park which intersects with Parkview Place, running in a westerly direction approximately 1,000 feet will, from this day forth, be known as Bennie Diegel Avenue.

**Section 3:** The Public Works Department is hereby directed to add street name signs as affected by this Ordinance.

**Section 4:** The City Secretary is hereby ordered to cause a certified copy of this Ordinance, attested to by the City Secretary under the seal of the City, to be recorded in the Office of the County Clerk of San Patricio County.

**Section 5:** The City Clerk is hereby directed to cause a certified copy of this Ordinance, attested to by the City Secretary under seal of the City, to be mailed to the following agencies:

- b) City of Ingleside Police Department
- c) City of Ingleside Fire Department
- d) 911 Addressing


