CITY OF BRADENTON BEACH ORDINANCE NO. 25-562

AN ORDINANCE OF THE CITY OF BRADENTON BEACH, FLORIDA AMENDING THE SECOND RESTATED FRANCHISE AGREEMENT WITH WASTE PRO OF FLORIDA, INC. AND, ITS SUCCESSORS AND ASSIGNS, AN EXCLUSIVE SOLID WASTE COLLECTION PROGRAM FRANCHISE; PROVIDING FOR A FIVE (5) YEAR EXTENSION; PROVIDING FOR FINDINGS OF FACT; PROVIDING FOR REPEAL OF ALL ORDINANCES IN CONFLICT; PROVIDING FOR SEVERABILITY; PROVIDING FOR CODIFICATION; AND PROVIDING FOR AN EFFECTIVE DATE.

BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF BRADENTON BEACH, FLORIDA, as follows:

WHEREAS, Article VIII, Section 2 of the Florida Constitution provides that municipalities shall have governmental, corporate and proprietary powers to enable municipalities to conduct municipal government, perform municipal functions and render municipal services; and,

WHEREAS, Chapter 166, Florida Statutes, the "Municipal Home Rule Powers Act," implements the applicable provisions of the Florida Constitution and authorizes municipalities to exercise any power for municipal purposes, except when expressly prohibited by law and to enact ordinances in furtherance thereof; and

WHEREAS, the City Commission of the City of Bradenton Beach, Florida recognizes that the City of Bradenton Beach and its citizens and businesses need and desire the benefits of a third-party solid waste service; and

WHEREAS, on or about April 11, 2011, the City entered into a Franchise Agreement for Solid Waste & Recycling Collection with Waste Pro of Florida, Inc., to provide the City with Solid Waste and Recycling Collection Services, which was restated in Ordinance 16-463 with an expiration date of May 31, 2025; and

WHEREAS, the City desires to amend the Agreement to extend the Solid Waste & Recycling Collection services of Waste Pro of Florida, Inc. through May 31, 2030.

WHEREAS, the City Commission of the City of Bradenton Beach has determined that the enactment of this Ordinance authorizing the execution of an extension to the Second Restated Franchise Agreement by and between the City of Bradenton Beach and Waste Pro of Florida, Inc. is for a proper municipal purpose and protects the public health, safety and welfare of its citizens and residents.

NOW THEREFORE, BE IT FURTHER ORDAINED BY THE CITY COMMISSION, AS FOLLOWS:

- 1. SECTION 1: TERM OF FRANCHISE is hereby amended to reflect that the Franchise Term shall be extended for five (5) years through May 31, 2030.
- 2. All other terms and conditions of the City of Bradenton Beach, Florida Second Restated Franchise Agreement for Collection and Disposal of Refuse and Residential Recyclable Materials remain in full force and effect.
