**AN ORDINANCE: AMENDING ARTICLE IV. DIVISION 3 ECONOMIC  
DEVELOPMENT ADVISORY COMMITTEE SECTIONS 2-  
339-34**

**BE IT ENACTED AND ORDAINED BY THE COUNCIL OF THE TOWN OF  
PURCELLVILLE THAT ARTICLE IV. ECONOMIC DEVELOPMENT ADVISORY  
COMMITTEE SECTIONS 2-342-346 ESTABLISHED; MEMBERSHIP; MEETINGS OF  
THE TOWN CODE OF THE TOWN OF PURCELLVILLE BE AMENDED AS  
FOLLOWS:**

**WHEREAS,** all references to “board” will be changed to “committee” throughout the  
Article; and

**WHEREAS,** the committee would like to amend its membership to allow non-resident  
business owners in the Town of Purcellville to serve on the committee.

**THEREFORE, BE IT RESOLVED,** that Sec. 2-342(a) be amended to read as follows:

Sec.2-342. - Established; membership; meetings.


(a) Composition; appointments and terms. The town economic development advisory committee is hereby established. Such committee shall consist of no more than ten members with priority given to residents from the town. In the event there are not enough residents to fill vacant positions, the town council may appoint non-resident town business owners and up to four non-residents, individuals who reside outside of the incorporated limits of the town, to serve. A member of council, appointed by the council, shall serve as an ex officio or non-voting member of the committee. The members shall be appointed by council to serve two-year staggered terms beginning September 1 of the year of appointment. Initial membership shall consist of four members appointed for terms of two years and three members shall be appointed for a term of one year.


