

ORDINANCE AMENDING SECTION 2-133 OF THE CODE OF ORDINANCES OF THE CITY OF BRANDON, MISSISSIPPI INCREASING THE NUMBER OF MEMBERS OF THE PLANNING COMMISSION

WHEREAS, the governing authorities of the City of Brandon, Mississippi find and determine that in order to facilitate a reasonable, orderly and timely process of evaluating and providing recommendations to the Mayor and Board of Aldermen regarding matters that are presented to the planning commission for consideration that Section 2-133 of the Code of Ordinances of the City should be amended increase the numbers of members of the planning commission; and now therefore

BE IT ORDAINED that Section 2-133 of the Code of Ordinances of the City of Brandon should be and the same is hereby amended to read in full as follows, to-wit:

Sec. 2-133. Membership.

(a) The city planning commission shall consist of eleven members who shall serve without pay and shall be residents of the city, and shall be appointed as follows:

- (1) One member appointed from ward one by the alderman for ward one.
- (2) One member appointed from ward two by the alderman for ward two.
- (3) One member appointed from ward three by the alderman for ward three.
- (4) One member appointed from ward four by the alderman for ward four.
- (5) One member appointed from ward five by the alderman for ward five.
- (6) One member appointed from ward six by the alderman for ward six.
- (7) One member appointed by the alderman at-large.
- (8) Four members appointed by the mayor.

\*\*\*\*\*

1. This Ordinance shall supersede any and all ordinances which are in conflict herewith.

2. In order to insure the reasonable, orderly and timely consideration of matters before the planning commission, in accordance with Miss. Code Ann. Section 21-13-11 (1972 as amended), this Ordinance shall go into effect immediately upon passage, with a unanimous vote of the members, and in the event the vote for passage is less than unanimous by the members present, this Ordinance shall go into effect one (1) month after passage.

3. The foregoing Ordinance having been first reduced to writing was read and considered and by motion of Alderman Morris and seconded by Alderman Vinson was adopted by the following vote, to wit:
