

**ORDINANCE 2023-19**

**AN ORDINANCE OF THE CITY OF TREASURE ISLAND, FLORIDA, AMENDING THE FISCAL YEAR 2024 GENERAL FUND BUDGET TO APPROPRIATE \$57,900 FOR THE REPAIR AND IMPROVEMENTS OF TENNIS COURTS AT TREASURE BAY FROM THE UNDESIGNATED FUND BALANCE, WHICH IS PARTIALLY FUNDED BY A UNITED STATES TENNIS ASSOCIATION GRANT IN THE AMOUNT OF \$41,000; PROVIDING FOR SEVERABILITY; CONFLICT; AND AN EFFECTIVE DATE.**

**WHEREAS**, pursuant to Ordinance 2023-16, the City of Treasure Island, Florida adopted an annual operating budget for fiscal year 2024; and

**WHEREAS**, the tennis courts at Treasure Bay were damaged from Hurricane Ian and will cost \$57,900 to repair and improve the courts to mitigate against future wind damage;

**WHEREAS**, the City has been awarded a \$41,000 grant from the US Tennis Association (USTA) for the repair and upgrade of our tennis amenities at Treasure Bay Golf & Tennis Center; and

**WHEREAS**, this ordinance is a budget amendment and therefore, pursuant to s. 166.041(4)(c), Fla. Stat., this ordinance is exempt from the business impact estimate requirement of s. 166.041(4)(a), Fla. Stat.; and

**WHEREAS**, pursuant to the City’s Charter and generally accepted accounting principles, the City finds it in the public’s best interest to amend the City’s budget to appropriate \$57,900 from the General Fund undesignated fund balance to repair and improve the tennis courts, which the costs will be partially funded from a USTA grant for \$41,000.

**NOW, THEREFORE, THE CITY OF TREASURE ISLAND DOES ORDAIN:**

**SECTION 1.** The recitals set forth in the “Whereas” clauses above are ratified and confirmed as true and correct and are hereby adopted as findings by the City Commission of the City of Treasure Island, Florida for the adoption of this Ordinance.

**SECTION 2.** The General Fund budget for the City of Treasure Island, Florida for the fiscal year 2024, as adopted pursuant to Ordinance 2023-16, is hereby amended by appropriating \$57,900 within the Recreation Program Budget from the undesignated fund balance (\$16,900) and grant revenues (\$41,000) to be used for the repair project.

**SECTION 3.** That allocation of said funds shall be as follows:

**SECTION 4. SEVERABILITY.** It is declared to be the intent of the City Commission, that if any section, subsection, sentence, clause, phrase, or portion of this Ordinance is for any reason held invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions thereof.

**SECTION 5. CONFLICT.** This action supersedes all ordinances and resolutions of the City or portions thereof, in conflict with or inconsistent with this ordinance, to the extent of such inconsistency or conflict.

**SECTION 6. EFFECTIVE DATE.** This Ordinance shall take effect immediately upon its final passage.

**SECOND READING and PUBLIC HEARING** on the 5<sup>th</sup> day of DECEMBER, 2023.


