

ORDINANCE # 1059

AN ORDINANCE TO AMEND CITY OF AVA CODE OF ORDINANCES CHAPTER 94 TRAFFIC AND VEHICLES SECTION 163 RIGHTS AND DUTIES OF RIDERS REVISING THAT PART OF THE ORDINANCE AND CHANGING TO AN UPDATED CHAPTER 94 TRAFFIC AND VEHICLES SECTION 163 RIGHTS AND DUTIES OF RIDERS.

WHEREAS, The Board of Aldermen of the City of Ava, Missouri wishes to promote the safety and welfare of the citizens of the City of Ava, Missouri, and

WHEREAS, It is deemed to be in the public interest for the city to enact ordinances to provide regulations regarding the safety and welfare of the citizens.

THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF AVA, MISSOURI THAT CHAPTER 94 SECTION 163 READ AS FOLLOWS:

Section 94-163.- Rights and duties of riders.


- (a) No person shall operate/ride upon any skateboard, roller skates, coasters, or any similar devices upon any roadway or sidewalk within the city limits of Ava.
- (b) No person shall operate motorized bicycles, electric scooters or any vehicle unlicensed by the State (excluding bicycles) upon the streets and sidewalks of the city.
- (c) Operator of bicycles must abide by all state laws and city ordinances regulating traffic within the city limits. For safety reasons a responsible adult will be accountable for minor children operating bicycles.
- (d) The operation of above listed items is excluded from this section when operated on private property, with the property owner's consent.

This ordinance shall take effect and be in force from and after its passage and approval by the Board of Aldermen of the City of Ava, Missouri. All ordinances or parts of ordinances in conflict with the terms hereof are void and of no effect.





WHEREAS, The Board of Aldermen of the City of Ava, Missouri wishes to promote the safety and welfare of the citizens of the City of Ava, Missouri, and

WHEREAS, It is deemed to be in the public interest for the city to enact ordinances to provide regulations regarding the safety and welfare of the citizens.

THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF AVA, MISSOURI THAT CHAPTER 94 SECTION 163 READ AS FOLLOWS:

Section 94-163.- Rights and duties of riders.

- (a) No person shall operate/ride upon any skateboard, roller skates, coasters, or any similar devices upon any roadway or sidewalk within the city limits of Ava.
- (b) No person shall operate any motorized vehicle, of any horsepower, motorized bicycles, electric scooters or any vehicle unlicensed by the state (RSMo 301.055) upon the streets and sidewalks of the city.
- (c) Operator of bicycles must abide by all state laws and city ordinances regulating traffic within the city limits. For safety reasons a responsible adult will be accountable for minor children operating bicycles.
- (d) The operation of above listed items is excluded from this section when operated on private property, with the property owner's consent.

This ordinance shall take effect and be in force from and after its passage and approval by the Board of Aldermen of the City of Ava, Missouri. All ordinances or parts of ordinances in conflict with the terms hereof are void and of no effect.
