ORDINANCE 11-09
ST. JAMES PARISH COUNCIL

AN ORDINANCE ESTABLISHING POLLING PLACES IN COMPLIANCE
WITH FEDERAL, STATE, AND LOCAL LAWS AND REGULATIONS, AS
AMENDED

WHEREAS, to provide safe and easy accessible polling places for all citizens, the Council is required to establish polling places in accordance with federal and state laws:

NOW, THEREFORE, THE ST. JAMES PARISH COUNCIL HEREBY ORDAINS and establishes polling places for all precincts as outlined in Exhibit "A", which is attached hereto and made part hereof, as recommended by the St. James Parish President and the Registrar of Voters, in compliance with Louisiana Revised Statutes 18:533 and other federal, state, and local regulations governing the reapportionment and election process; and,


BE IT, FURTHER, ORDAINED that any other ordinances or resolutions setting forth polling places in conflict herewith are hereby repealed.
