The following ordinance which was previously introduced at a regular meeting held on January 11, 2017, a summary thereof having been published in the official journal together with a notice of public hearing which was held in accordance with said public notice, was brought up for final passage on motion of Councilman Amato and seconded by Councilman Kraemer:

**ORDINANCE 17-01
ST. JAMES PARISH COUNCIL**

AN ORDINANCE AMENDING CHAPTER 2, ARTICLE II, SECTION 2-36, OF THE ST. JAMES PARISH CODE OF ORDINANCES MAKING A TEMPORARY REVISION OF THE PARISH COUNCIL MEETING SCHEDULED FOR THE SECOND WEDNESDAY (FEBRUARY 8, 2017) OF THE MONTH OF FEBRUARY, 2017 TO THE SECOND TUESDAY (FEBRUARY 7, 2017) OF THE MONTH OF FEBRUARY, 2017

WHEREAS, the St James Parish Home Rule Charter, Article III, Section (A)(5)(c) provides that the Council shall meet regularly at such times as may be prescribed by its rules, but not less frequently than twice each month and the Parish Council meeting schedule is provided in the St. James Parish Code of Ordinances, Chapter 2, Article II, Section 2-36;

WHEREAS, the St. James Parish Council desires to temporarily revise its regular meeting schedule and as such, reschedule the February 8th meeting to February 7, 2017 and shall provide the public proper notice in compliance with the Louisiana Open Meetings Law (La. R.S. 42:11 et seq.) and this revision shall not be permanent.

WHEREAS, The St. James Parish Council further desires that any future changes in said meeting schedule which is not meant to be permanent may be done by resolution duly adopted by a majority vote of the Council and that any permanent change in the meeting be done by amendment to the ordinance duly adopted by a majority vote of the Council.


NOW, THEREFORE, BE IT ORDAINED, that the St. James Parish Council, amending Chapter 2, Article II, Section 2-36 of the St. James Parish Code of Ordinances temporarily rescheduling the meeting to be held on the second Wednesday in February (February 8, 2017) to the second Tuesday in February (February 7, 2017) to be held in the Council Chambers located in the Parish Administrative Building in Convent, Louisiana at 6:30 p.m., and shall provide the public proper notice in compliance with the Louisiana Open Meetings Law (La. R.S. 42:11 et seq.).

NOW THEREFORE BE IT FURTHER ORDAINED by the St. James Parish Council that this temporary revision in the regular meeting schedule shall not be permanent and the Council meeting schedule shall revert back to the prior schedule thereafter and that any future revision hereinafter in the regular Council meeting schedule which is not meant to be permanent may be done by resolution duly adopted by a majority vote of the Council and that any permanent change in the regular Council meeting schedule be done by amendment to the ordinance duly adopted by a majority vote of the Council.


This ordinance having been submitted to a vote, the vote thereon was as follows:
