

# **ORDINANCE 2024-1889**

## **AMENDMENT TO CITY OF MARTINSVILLE SEWER USE ORDINANCE, ORDINANCE NO. 2005-1554**

Comes now the Common Council with the City of Martinsville, Indiana, and pursuant to I.C. 36-9-2-16 and 36-9-30-21, amends the City of Martinsville Sewer Use Ordinance, Ordinance 2005-1554. The Common Council now finds that it is in the best interest of the City that the Ordinance be amended to read as follows:

### **SECTION 2 – GENERAL SEWER USE REQUIREMENTS**

#### **2.1 Prohibited Discharge Standards**

##### **B. Specific Prohibitions.**

(2) Wastewater having a pH less than 5.0 or more than 10.0, or otherwise causing corrosive structural damage to the POTW or equipment;

Further, Section 10 – Administrative Enforcement Remedies should now be modified as follows:





### **SECTION 10 – ADMINISTRATIVE ENFORCEMENT REMEDIES**

#### **10.6 Administrative Fines**


A. When the Board finds that a user has violated, or continues to violate, any provision of this ordinance, a wastewater discharge permit or order issued hereunder, or any other pretreatment standard or requirement, the Board shall fine each user the amount of \$2,500.00 for the first violation. If there is a second violation, then the fine shall be \$5,000.00. Three or more violations shall be \$7,500.00 each. Such fines shall be assessed on a per violation, per day basis. In the case of monthly or other long term average discharge limits, fines shall be assessed for each day during the period of violation.

All other provisions of the City of Martinsville Sewer Use Ordinance, Ordinance No. 2005-1554 shall remain in full force and effect if not changed by this Amendment.


