

ORDINANCE NO. O-22-01
ORDER FOR CITY OFFICERS ELECTION

I, Kyle Kutch, in my capacity as Mayor of the City of White Oak, Texas do hereby order that a joint election be held in said City on the 7th day of May 2022 for the purpose of electing the following officials for said City:

MAYOR
COUNCIL MEMBER PLACE 4
COUNCIL MEMBER PLACE 5

The City will contract with the elections administrator of Gregg County to conduct all aspects of the Election; and the Election will be conducted by each County and held jointly with other political subdivisions for which each County is also conducting their elections (such other political subdivisions, collectively, the Participants), as provided pursuant to the provisions of an election agreement and/or a joint election or similar agreement between or among (as applicable) the City, each County, and/or any Participants, entered into in accordance with the provisions of Section 271.002, as amended, Texas Election Code; and

GREGG COUNTY ELECTION DAY PRECINCT AND POLLING INFORMATION

- Election Day: Saturday, May 7, 2021
- Election Day Polling Locations open from 7 a.m. to 7 p.m. and are determined by the county utilizing the countywide polling place program under Section 43.007, as amended, Texas Election Code. Registered voters will be able to cast their Election Day ballots at any of the Vote Centers identified on Gregg County's website.
- Presiding Judges and Alternates: to be appointed by the County

GREGG COUNTY EARLY VOTING LOCATIONS, DATES, AND HOURS

- Early voting begins Monday, April 25, 2021, and ends on Tuesday, May 3, 2021.
- Early Voting Clerk: Jennifer Briggs, P.O. Box 2827, Longview, Texas, 75601.
- Presiding Judge of the Early Voting Ballot Board: to be determined by Gregg County Early Voting Clerk.
- Voters entitled to vote an early ballot by personal appearance may do so at any Early Voting site identified on Gregg County's website.

The Gregg County early voting clerk's mailing address is P.O. Box 2827, Longview, Texas 75601, to which ballot applications and ballots voted by mail may be sent.

Early voting by mail shall be by paper ballots and voting by personal appearance shall be by a Verity DUO voting system approved by the Secretary of State of Texas and shall be canvassed by an Early Voting Ballot Board, appointed by Gregg County Commissioners Court.

The period for early voting by personal appearance in Gregg County for the above designated election will be conducted:

Monday, April 25, 2021 through Friday, April 29, 2021	8:00 AM to 5:00 PM
Monday, May 2, 2021 through Tuesday, May 3, 2021	7:00 AM to 7:00 PM


Early voting by mail shall be by paper ballots and voting by personal appearance shall be by a Verity DUO voting system approved by the Secretary of State of Texas and shall be canvassed by an Early Voting Ballot Board, appointed by Gregg County Commissioners Court.

The order in which the names of the candidates are to be printed on the ballot shall be determined by a drawing by the City Clerk as provided in Section 52.094 of the Election Code.

Said election shall be held in accordance with the Election Code of this State, and only resident qualified voters of said City shall be eligible to vote at said election.


The Gregg County Election Administrator and the City of White Oak shall give notice of this election in accordance with the terms and provisions of Section 4.004, 83.010, 85.004 and 85.007 of the Election Code, and all necessary orders and writs for said election shall be issued by the proper authority.
