PROPOSED AMENDMENTS TO EXETER CODE OF ORDINANCES

Chapter 34 Solid Waste
Article II. Collection and Disposal

Sec. 34-32. Definitions. (New definition added)

Resident is defined as a “Legally Domiciled Resident” who is a person who is or is eligible to become a qualified elector in the town and who actually resides in the town.

Subdivision V. User Fees

Sec. 34-153. Permits.

The fees for permits shall be as follows:

- (1) Annual permit. The fee for annual permits shall be \$190.00. A second permit (same household) shall be \$90.00.
- (2) Annual permit; senior citizens (age 65 or older). The fee for annual permits issued to senior citizens shall be \$90.00.
- (3) Single use permit: \$50.00
- (4) Recycling only permit: No fee.
- (5) Special needs permit: \$120.00
- (6) New residents (one year or less occupancy) sliding scale: The fee for annual permits shall be pro-rated accordingly for new residents to the town. Proof of new residency must be provided at the time of permit purchase and must include the purchaser's name and Exeter address as identified by the following documents:
 - Recorded deed or signed lease agreement;
 - Vehicle registrations from previous address and new address;
 - Utility bills (telephone, electric, cable).

The pro-rated fee schedule for new residents shall be applied according to the start date of residency and not at the date of permit purchase as follows:

- a. October 1—December 31 \$190.00
- b. January 1—March 31 \$170.00
- c. April 1—June 30 \$130.00
- d. July 1—September 30 \$110.00

Sec. 34-154. Bulky waste; restricted items; hard to dispose items.

Until otherwise amended by resolution of the town council and/or upon any increase in coincident disposal fees charged to the town by any governing state agency or destination

disposal facility, the fees for bulky waste, restricted items, and hard to dispose of items shall be as follows:

Sec. 34-158. Enforcement.

(a) *Enforcing officer.* It shall be the duty of the town sergeant to enforce this article.

(b) *Penalties for violations.* Penalties for violations shall be issued as follows:

(1) Residents violating section 34 [this division]:

- a. First offense: Written warning.
- b. Second offense: \$100.00
- c. Subsequent offense: \$200.00
- d. Loss of Transfer Station Permit.
