

**CITY OF KENEDY, TEXAS
ORDINANCE NO. 18-16**

AN ORDINANCE OF THE CITY OF KENEDY, TEXAS, AMENDING ORDINANCE NO. 18-1 RELATING TO FEES ASSESSED FOR SOLID WASTE COLLECTION AND DISPOSAL SERVICE; ESTABLISHING FEES TO BECOME EFFECTIVE JANUARY 1, 2019; PROVIDING FOR DELINQUENT PAYMENT; CONTAINING A SAVING CLAUSE; AND REPEALING ALL ORDINANCES IN CONFLICT HEREWITH.

WHEREAS, collection and disposal of solid waste in a community is essential to maintain acceptable health and sanitation standards;

WHEREAS, the City of Kenedy has entered into a Contract with Progressive Waste Solutions of Texas, Inc. (Progressive) for the collection and disposal of solid waste;

WHEREAS, the Contract includes provisions for annual adjustments to Progressive's cost of solid waste collection and disposal service based on changes in the Consumer Price Index, Fuel Cost, and Landfill Disposal Costs;

WHEREAS, Progressive has presented the City a request for Rate Adjustments to become effective January 1, 2019; and,

WHEREAS, the City finds Progressive's request to be in accordance with the Contract provisions.

NOW, THEREFORE, BE IT ORDAINED BY THE KENEDY CITY COUNCIL THAT:

SECTION 1. Progressive's rates and fees have been approved and are incorporated into the City's Solid Waste Collection and Disposal Fees to become effective January 1, 2019 as shown on the attached Exhibit A to this Ordinance.


SECTION 2. Customers who become delinquent in the payment of their monthly bill for solid Waste Collection and Disposal Service shall be assessed a late charge in the amount of fifteen percent (15%) of the delinquent bill.

SECTION 3. All ordinances or parts of ordinance in conflict herewith are hereby repealed.

SECTION 4. If any provision of this Ordinance or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications of this Ordinance which can be effective without the invalid provision or application, and to this end the provisions of this Ordinance are declared to be severable.
