

Village of Menomonee Falls Ordinance No. 834-O-21

AN ORDINANCE AMENDING CHAPTER 30
OF THE MUNICIPAL CODE OF THE VILLAGE OF MENOMONEE FALLS
REGARDING WARDS AND POLLING PLACES

WHEREAS, the Village Board is required to approve a ward plan within 60 days after its ward boundaries have been readjusted as required by Sec. 5.15, Wis. Stats.; and

WHEREAS, said ward plan has been approved by resolution as required by law; and

WHEREAS, Sec. 5.15 requires that an ordinance designating the polling places for each ward must be approved by the governing body.

NOW, THEREFORE BE IT RESOLVED, the Board of Trustees of the Village of Menomonee Falls hereby ordain as follows:

Section 1. Article II. Wards and Polling Places, Chapter 30, Section 30-21 and 30-22, of the Municipal Code is hereby repealed and recreated as follows:

Sec. 30-21. Election wards.

The Village is divided into 24 election wards with polling places, all as provided in this article.

Sec. 30-22. Polling places.

Section 3. This ordinance shall take effect on January 1, 2022

Section 4. SEVERABILITY. If a court of competent jurisdiction adjudges any section, clause, provision or portion of this ordinance unconstitutional or invalid, the remainder of this ordinance shall not be affected thereby.




