

Village of Menomonee Falls Ordinance No. 894-O-23

**AN ORDINANCE APPROVING THE 2024 BUDGET, RELATED TAX LEVY,
AND GARBAGE & RECYCLING SPECIAL CHARGE**

Appropriating the necessary funds for the operation of the government and administration of the Village of Menomonee Falls for the year 2024; the Board of Trustees of the Village of Menomonee Falls, Wisconsin, do ordain as follows:

Section 1. There is hereby appropriated out of the receipts of the Village of Menomonee Falls for the year 2024, including monies received from the general property tax levy, to the various purposes specified in the budget presented herewith for the purposes therein stated, the following amounts:

Section 6. A separate fee for Garbage & Recycling in the amount of \$169.08 is to be included as a special charge on the tax bill for each residential unit within the Village (up to four units).

Section 7. The Village Clerk is hereby authorized and directed to place the tax and the special charge on the current tax roll of the Village of Menomonee Falls.

Section 8. This ordinance shall take effect and be in force from and after its passage and publication.
