

Village of Menomonee Falls Ordinance No. 895-O-23

AN ORDINANCE AMENDING CHAPTER 30
OF THE MUNICIPAL CODE OF THE VILLAGE OF MENOMONEE FALLS
REGARDING WARDS AND POLLING PLACES

WHEREAS, Pursuant to Wis. Stat. 5.25(3), the location of polling places shall be determined by the Board of Trustees at least 30 days before an election; and

WHEREAS, it is deemed prudent of the Village of Menomonee Falls to change and combine polling locations due to facility construction and limited space for voter accessibility and equipment needs.

NOW, THEREFORE BE IT RESOLVED, the Board of Trustees of the Village of Menomonee Falls hereby ordain as follows:

Section 1. Article II. Wards and Polling Places, Chapter 30, Section 30-21 and 30-22, of the Municipal Code is hereby repealed and recreated as follows:

Sec. 30-21. Election wards.

The Village is divided into 26 election wards with polling places, all as provided in this article.

Sec. 30-22. Polling places.

Section 3. This ordinance shall take effect on January 1, 2024
