

**Village of Menomonee Falls Ordinance No. 902-O-24**

**AN ORDINANCE ESTABLISHING CERTAIN TRAFFIC REGULATIONS IN THE  
FOX RIVER FALLS SUBDIVISION (PHASES 1-3), VILLAGE OF MENOMONEE  
FALLS**

**WHEREAS**, Wisconsin Statute § 61.34(1) provides in part that except as otherwise provided by law, the Village Board shall have the management and control of the Village highways and streets, and the power to act for the government and good order of the Village, for its commercial benefit and for the health, safety, welfare and convenience of the public, and may carry its powers into effect by various means authorized by that statute; and that the powers thereby conferred are addition to all other grants and limited only by express language; and

**WHEREAS**, Wisconsin Statutes § 349.03 authorizes the Village to enact and enforce traffic regulations that are not contrary to or inconsistent with Chapters 341 to 348 and 350 of the Wisconsin Statutes; or are expressly authorized by Wisconsin Statutes §§ 349.06 to 349.25 or some other provision of the statutes; and

**WHEREAS**, § 106-41(a) of the Municipal Code of the Village of Menomonee Falls provides that permanent traffic regulations shall be established by the Village Board of Trustees; and;

**WHEREAS**, the Village staff recommends that the Village Board approve the following traffic regulations:

- 1) “Stop” Sign on Turnberry Lane southbound at its intersection with Silver Spring Drive (CTH “VV”); and
- 2) “Stop” Sign on Carnoustie Way southbound at its intersection with Silver Spring Drive (CTH “VV”); and
- 3) “Yield” Sign on Lomond Road westbound at its intersection with Turnberry Lane; and
- 4) “Yield” Sign on Lomond Road eastbound at its intersection with Muirfield Drive; and
- 5) “Yield” Sign on Dunbar Ct eastbound at its intersection with Muirfield Drive; and
- 6) “Yield” Sign on Carnoustie Way eastbound at its intersection with Turnberry Lane; and
- 7) “Yield” Sign on Carnoustie Way westbound at its intersection with Turnberry Lane; and
- 8) “Yield” Sign on Carnoustie Way eastbound at its intersection with Muirfield Drive; and

- 9) “Yield” Sign on Muirfield Drive westbound at its intersection with Turnberry Lane; and
- 10) “Speed Limit 25 MPH” Sign on Turnberry Lane northbound just north of Silver Spring Dr (CTH “VV”); and
- 11) “Speed Limit 25 MPH” Sign on Carnoustie Way northbound just north of Silver Spring Dr (CTH “VV”).

**WHEREAS**, the Utilities & Public Works Committee of the Village Board has considered the above request and recommended that the Village Board approve the request regulations; and

**WHEREAS**, the Village Board finds that it will further public safety and is in the best interests of the Village of Menomonee Falls to adopt the regulations recommended by Village staff and the Utilities and Public Works Committee.

**NOW THEREFORE**, the Board of Trustees of the Village of Menomonee Falls do hereby ordain as follows:

**Section 1.** The following traffic regulations are approved; and the permanent traffic regulations currently in affect in the Village of Menomonee Falls are amended to add the following regulations, which shall also be added to the official records on file in the Village Clerk’s office and the Police Department:

**Stop Right of Way Intersections:**

- 1) “Stop” Sign on Turnberry Lane southbound at its intersection with Silver Spring Drive (CTH “VV”); and
- 2) “Stop” Sign on Carnoustie Way southbound at its intersection with Silver Spring Drive (CTH “VV”); and

**Yield Right of Way Intersections:**

- 3) “Yield” Sign on Lomond Road westbound at its intersection with Turnberry Lane; and
- 4) “Yield” Sign on Lomond Road eastbound at its intersection with Muirfield Drive; and
- 5) “Yield” Sign on Dunbar Ct eastbound at its intersection with Muirfield Drive;
- 6) “Yield” Sign on Carnoustie Way eastbound at its intersection with Turnberry Lane;
- 7) “Yield” Sign on Carnoustie Way westbound at its intersection with Turnberry Lane;

- 8) “Yield” Sign on Carnoustie Way eastbound at its intersection with Muirfield Drive;
- 9) “Yield” Sign on Muirfield Drive westbound at its intersection with Turnberry Lane;

**Speed Limit:**

- 10) “Speed Limit 25 MPH” Sign on Turnberry Lane northbound just north of Silver Spring Dr (CTH “VV”); and
- 11) “Speed Limit 25 MPH” Sign on Carnoustie Way northbound just north of Silver Spring Dr (CTH “VV”).

**Section 2.** Pursuant to § 106-41 of the Municipal Code, the Village Manager or the Village Manager’s designee is authorized to erect and maintain appropriate standard traffic signs, signals and markings giving notice of these traffic regulations.

**Section 3.** Except as specifically modified and amended by this ordinance, the Municipal Code of the Village of Menomonee Falls shall remain in force and effect exactly as originally adopted and previously amended. All ordinances or parts of ordinances inconsistent with or in contravention of the provisions of this ordinance are hereby repealed.

**Section 4.** This ordinance shall take effect and be in full force from and after its passage.

**Section 5.** If a court of competent jurisdiction adjudges any section, clause, provision or portion of this ordinance unconstitutional or invalid, the remainder of this resolution shall not be affected thereby.
