

**CITY OF LAKE DALLAS, TEXAS
ORDINANCE NO. 20158-15**

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LAKE DALLAS, TEXAS, CANVASSING THE RETURNS AND DECLARING THE RESULTS OF THE CITY'S SPECIAL ELECTION HELD ON MAY 5, 2018, ON A PROPOSITION TO REAUTHORIZE A LOCAL SALES AND USE TAX TO PROVIDE REVENUE FOR MAINTENANCE AND REPAIR OF MUNICIPAL STREETS; PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City Council of the City of Lake Dallas, Texas called a special election to be held in the City on May 5, 2018, on a proposition to reauthorize the local sales and use tax in the City of Lake Dallas, Texas, at the rate of one-fourth of one percent to provide revenue for maintenance and repair of municipal streets; and

WHEREAS, immediately after said election the Presiding Judge and other officials holding said election made the returns of the results thereof to the City as set forth herein, and said returns being made according to law, and duly authenticated, being shown that written notice of said election was posted for the time and manner provided by law, and all other proceedings pertaining to said election have been shown to have been done and performed at and within the manner provided by law, and all papers pertaining thereto having been returned and filed with the City and no protest or objection being made to or regarding any matter pertaining to said election.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LAKE DALLAS, TEXAS, THAT:

SECTION 1. After examining the election returns and opening, tabulating and canvassing the votes of the special election of May 5, 2018, the results of said election as to the proposition is as follows:

PROPOSITION A - The reauthorization of the local sales and use tax in the City of Lake Dallas at the rate of one-fourth of one percent to continue providing revenue for maintenance and repair of municipal streets. The tax expires on the 10TH anniversary of the date of this election unless the imposition of the tax is reauthorized.

SECTION 2. Said election was duly called, that notice of said election was given in accordance with law, that said election was held in accordance with law, and that each proposition received a majority of all votes cast for each proposition in favor of passage and enactment. The above propositions are hereby declared duly passed.

SECTION 3. The election was duly called, notice of said election was given in accordance with law, said election was held in accordance with law, and since a majority of the votes cast in said election were in favor of the foregoing proposition, the measures passed, and additional sales of one-fourth of one percent for maintenance and repair of municipal streets shall be imposed for a period of ten additional years.

SECTION 4. Should any part, section, subsection, paragraph, sentence, clause or phrase contained in this ordinance be held to be unconstitutional, invalid or unenforceable, such holding shall not affect the validity of the remaining portion of this ordinance, but in all respects said remaining portion shall be and remain in full force and effect.

SECTION 5. This Ordinance declaring the results of the May 5, 2018, election shall become effective immediately from and after its passage, as the law and Charter in such cases provide.
