## **TOWN OF FLOWER MOUND, TEXAS**

### ORDINANCE NO. 02-21

AN ORDINANCE OF THE TOWN COUNCIL OF THE TOWN OF FLOWER MOUND, TEXAS, AMENDING APPENDIX A "FEE SCHEDULE," OF THE CODE OF ORDINANCES, TOWN OF FLOWER MOUND, TEXAS; ESTABLISHING THE FEE FOR LEASE OF TOWN FACILITIES TO LEWISVILLE INDEPENDENT SCHOOL DISTRICT, PER A FACILITIES USE AGREEMENT; PROVIDING THIS ORDINANCE SHALL BE CUMULATIVE OF ALL ORDINANCES; PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING AN EFFECTIVE DATE.

**WHEREAS**, the Town of Flower Mound is a home rule municipality acting under its charter adopted by the electorate pursuant to Article XI, Section 5, of the Texas Constitution and Chapter 9 of the Local Government Code; and

**WHEREAS**, the Town Council of the Town of Flower Mound has previously adopted a Fee Schedule as Appendix A to the Town's Code of Ordinances; and

**WHEREAS**, the Town of Flower Mound has entered into a Facilities Use Agreement on or about September 15, 2020, and as part of that agreement will offer the lowest rates the Town offers to any person or group; and

**WHEREAS**, the Town Council wishes to amend the Fee Schedule to reflect rates for rental of Town-owned facilities to Lewisville Independent School District.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF FLOWER MOUND, TEXAS:

### **SECTION 1**

That Appendix A of the Code of Ordinances, Town of Flower Mound, Texas, is hereby amended by amending the schedule of fees regarding Rental Rates, to add specific rental rates applicable to Lewisville Independent School District (LISD) under the Facilities Use Agreement to read as follows:

## **SECTION 2**

This Ordinance shall be cumulative of all provisions of ordinances and of the Code of Ordinances of the Town of Flower Mound, Texas, as amended, except when the provisions of this Ordinance are in direct conflict with the provisions of such ordinances and such code, in which event the conflicting provisions of such ordinances and such code are hereby repealed.

## **SECTION 3**

It is hereby declared to be the intention of the Town Council that the sections, paragraphs, sentences, clauses, and phrases of this Ordinance are severable, and if any section, paragraph, sentence, clause, or phrase of this Ordinance shall be declared unconstitutional by the valid judgment or decree of any court of competent jurisdiction, such unconstitutionality shall not affect any of the remaining sections, paragraphs, sentences, clauses, and phrases of this Ordinance, since the same would have been enacted by the Town Council without the incorporation in this Ordinance of any such unconstitutional section, paragraph, sentence, clause or phrase.

### **SECTION 4**

This Ordinance shall be in full force and effect from and after the date of its passage and publication as required by law, and it is so ordained.
