ORDINANCE NO. 08-21

AN ORDINANCE OF THE TOWN OF FLOWER MOUND, TEXAS, AMENDING APPENDIX A, "FEE SCHEDULE," REFERENCED IN CHAPTER 14, "BUILDINGS AND BUILDING REGULATIONS," SECTION 14-1, ENTITLED "BUILDING, PLUMBING, MECHANICAL AND ELECTRICAL PERMIT FEES," OF THE CODE OF ORDINANCES, TOWN OF FLOWER MOUND, TEXAS, TO REVISE THE FEES RELATED TO THE ISSUANCE OF CERTAIN BUILDING PERMITS; PROVIDING THIS ORDINANCE SHALL BE CUMULATIVE OF ALL ORDINANCES; PROVIDING A SEVERABILITY CLAUSE; PROVIDING A SAVINGS CLAUSE; PROVIDING A PENALTY; PROVIDING FOR PUBLICATION; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Town of Flower Mound is a home rule municipality acting under its charter adopted by the electorate pursuant to Article XI, Section 5, of the Texas Constitution and Chapter 9 of the Local Government Code; and,

WHEREAS, the Town Council of the Town of Flower Mound has previously adopted regulations for the issuance of building permits within the Town and has provided for the collection of fees in connection therewith; and

WHEREAS, the Town Council now desires to update and amend the Appendix A, "Fee Schedule," to comply with changes in state law related to the issuance of certain building permits; and

WHEREAS, the Town Council finds and determines that the fees corresponding to Chapter 14, "Buildings, and Building Regulations" of Appendix A, "Fee Schedule," should be amended as set out herein and that the amendments proposed are in the best interest of and are necessary to protect the health, safety, and general welfare of the citizens of the Town and the general public;

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF FLOWER MOUND, TEXAS, THAT:

SECTION 1

Appendix A, "Fee Schedule," of the Code of Ordinances, Town of Flower Mound, Texas is hereby amended by revising fees corresponding to Chapter 14, "Buildings and Building Regulations," Section 14-1, "Building, plumbing, mechanical and electrical permit fees," to read as follows:

Chapter 14. Buildings and Building Regulations.

14-1	Building, plumbing, mechanical and electrical permit fees:

- When a building, plumbing, mechanical or electrical permit is required by the building, plumbing, mechanical or electrical code adopted by the Town of Flower Mound, the following fees shall be assessed. Inspection fees are included with the permit fee unless otherwise indicated in sub-section "f" below.
 - a) New single-family fees (including duplexes):

- b) New multifamily fees (3 attached units or more):
 - 1) \$500.00 per unit
 - 2) A nonrefundable plan review fee equal to 65 percent (65%) of the building permit fee is due at time of plan submittal.

c) New commercial fees:

- 1) Building permit fees for new construction:
 - a. 1,000 sq. ft. or less: \$450.00
 - b. 1,001 sq. ft. or more: \$330.00+\$0.12/sq. ft.
 - c. Fees for tenant finish out and shell buildings will be 75 percent (75%) of the above fees.
 - d. A nonrefundable plan review fee equal to 65 percent (65%) of the building permit fee is due at time of plan submittal.
- 2) Plumbing, mechanical and electrical fees for new construction (each):
 - a. 1,000 sq. ft. or less: \$200.00
 - b. 1,001 sq. ft. or more: \$140.00 + \$0.06/sq. ft.
 - c. Fees for tenant finish out and shell buildings will be 75 percent (75%) of the above fees.
- d) Fees for additions, alterations, repairs, demolition, screening walls, retaining walls and accessory buildings. The following fees shall be charged for small construction jobs involving additions, alterations and repairs. Projects that involve substantial work shall be charged as new construction at the discretion of the building official.

- f) Inspection fees: Fees for the associated inspection activities are as follows:
 - 1) Reinspection fee: \$100.00
 - 2) Tree re-inspection fee: \$50.00
 - 3) After hours inspection, per hour (minimum 2 hours): \$60.00
 - 4) Special inspection: \$60.00
 - 5) High-hazard inspection, annual: \$50.00
- g) *Drainage Inspection Fees.* Fees for drainage inspection are in addition to their corresponding building permit fees and shall be assessed as follows:

SECTION 2

This Ordinance shall be cumulative of all provisions of ordinances and of the Code of Ordinances, Town of Flower Mound, Texas, as amended, except where the provisions of this Ordinance are in direct conflict with the provisions of such ordinances and such code, in which event the conflicting provisions of such ordinances and such code are hereby repealed.

SECTION 3

It is hereby declared to be the intention of the Town Council that the phrases, clauses, sentences, paragraphs and sections of this Ordinance are severable, and if any phrase, clause, sentence, paragraph or section of this Ordinance shall be declared unconstitutional by a valid judgment or decree of any court of competent jurisdiction, such unconstitutionality shall not affect any of the remaining phrases, clauses, sentences,

paragraphs and sections of this Ordinance, since the same would have been enacted by the Town Council without the incorporation in this Ordinance of any such unconstitutional phrase, clause, sentence, paragraph or section.

SECTION 4

Any person, firm or corporation who violates any provision of this Ordinance shall be deemed guilty of a misdemeanor and, upon conviction thereof, shall be punished by a fine as provided in Section 1-13 of the Code of Ordinances, Town of Flower Mound, Texas. Each day any such violation or violations exist shall constitute a separate offense and shall be punishable as such.

SECTION 5

All rights and remedies of the Town of Flower Mound, Texas, are expressly saved as to any and all violations of the provisions of the Code of Ordinances or any other ordinances affecting the matters regulated herein which have accrued at the time of the effective date of this Ordinance; and, as to such accrued violations and all pending litigation, both civil and criminal, whether pending in court or not, under such ordinances, same shall not be affected by this Ordinance but may be prosecuted until final disposition by the courts.

SECTION 6

The Town Secretary of the Town of Flower Mound, Texas, is hereby directed to publish the caption of this Ordinance in the official newspaper of the Town of Flower Mound, Texas, as required by Section 3.07 of the Charter of the Town of Flower Mound, Texas.

SECTION 7

This Ordinance shall take effect and be in full force from and after the date of its passage and publication.
