**THE CITY COUNCIL OF EXCELSIOR, MINNESOTA, HEREBY ORDAINS:**

**SECTION ONE:** That Article 62, Section 62-6, of the City of Excelsior, Minnesota, Zoning Code is hereby amended to read as follows:

**62-6: DESIGNATION OF DISTRICTS/SITES:** With the addition of the following:

- H. 635 Glencoe Road: The Council of the City of Excelsior does hereby designate 635 Glencoe Road, P.I.D. #34-117-23-24-0002. This imposing house .... support the designation of this property as a heritage preservation site.

**SECTION TWO:** Effective Date: This ordinance shall be in effect 30 days after publication.

**THE CITY COUNCIL OF EXCELSIOR, MINNESOTA, HEREBY ORDAINS:**

**SECTION ONE:** That Article 62, Section 62-6, of the City of Excelsior, Minnesota, Zoning Code is hereby amended to read as follows:

**62-6: DESIGNATION OF DISTRICTS/SITES:** With the addition of the following:

- H. 635 Glencoe Road: The Council of the City of Excelsior does hereby designate 635 Glencoe Road, P.I.D. #34-117-23-24-0002. This imposing house, designed in the traditional gable-and-wing form with Queen Anne decorative detail, was built on a hilly site overlooking Glencoe Road. The intersecting gable roofs have decorative trim in the gable ends. A rear wing is fronted by a one-story porch. Another porch was originally located at the front of the house. The house may have been constructed by Rosa and Joseph Wright, who acquired the property in 1888 and took out a mortgage on the property in 1891. A house is shown on the 1898 Dahl map, and the form and stylistic details are characteristic of the 1890s. After the Wrights defaulted on their mortgage, the property was acquired by George and Louisa Raitz in 1901. Raitz was a grocery merchant in Excelsior and a Civil War veteran. The Raitzes sold the house to Francis and Ida Willis in 1908. Since 1958, the house has been owned by Chase and Sue Cornelius. Its identification with a person who significantly contributed to the culture and development of the city, its embodiment of distinguishing characteristics of an architectural style, period, form, or treatment, and its unique location, scale, or other physical characteristic representing an established and familiar visual feature of a neighborhood, a district, the community, or the city all support the designation of this property as a heritage preservation site.

**SECTION TWO: Effective Date:** This ordinance shall be in effect 30 days after publication.

**SECTION THREE: Legal Description:** Attached hereto as Exhibit A is a copy of the legal description for the property located at 635 Glencoe Road, P.I.D. #34-117-23-24-0002.
