An Ordinance Amending the Salary of the Village Clerk

WHEREAS, the Village of Norridge ("Village"), as a home rule municipality in accordance with Article VII Section 6(a) of the Constitution of the State of Illinois of 1970, is enacting this Ordinance pursuant to its home rule authority; and

WHEREAS, the Village Board of Trustees ("Village Board") has previously directed certain duties to be performed by the Village Clerk and previously set a salary for the Village Clerk by ordinance (Ordinance No. 2013-20); and

WHEREAS, the Village Board, after consultation Village officials, is recommending that the salary of the Village Clerk be increased following the 2025 Consolidated General Election and only upon the beginning of the term of the duly elected Village Clerk assuming that office following that certain election; and

WHEREAS, the Village Board finds it to be in the best interests of the Village to amend Chapter 2, Article III of the Revised Municipal Code of the Village of Norridge – 2002 ("Code") by enacting the amendment to the Code as set forth below to enhance Village municipal services to its residents which will benefit the health, safety and welfare of the citizens of the Village.

NOW THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF NORRIDGE, COOK COUNTY, ILLINOIS, as follows:

Section 1.

The facts and statements contained in the preamble to this Ordinance are found to be true and correct and are hereby adopted as part of this Ordinance.

Section 2.

That Chapter 2, Article III, Section 2-136 of the Revised Municipal Code of the Village of Norridge – 2002 is be and hereby is amended as set forth herein:

CHAPTER 2 – ADMINISTRATION

ARTICLE III. - VILLAGE CLERK

[. . .]

Sec. 2-136. - Compensation.

The compensation of the village clerk shall be the sum of \$16,000 per year to be paid out of general funds from the proper appropriation for all his or her services, including attending meetings of the village board, keeping minutes, records, seal and files and recording the same; for his other clerical duties relating to the general business of the village; and such other duties as shall be assigned to him by the board of trustees. Such salary shall be paid in monthly installments. There shall be no employee benefits accorded to the village clerk other than the compensation set out above. All fees of the office shall be turned into the village treasurer.

[. . .]

Section 3.

All ordinances or parts of ordinances in conflict herewith are hereby repealed.


Section 4.

This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law with the amendments to Code Section 2-136. – “*Compensation*” set forth in Section 2 herein becoming effective following the 2025 Consolidated General Election and only upon the beginning of the term of the duly elected Village Clerk assuming that office following that certain election.

Section 5.

If any provision of this Ordinance, or the application of any provision of this Ordinance, is held unconstitutional or otherwise invalid, such occurrence shall not affect other provisions of this Ordinance or their application if they can be given effect without the unconstitutional or invalid provision or its application. Each unconstitutional or invalid provision is severable, unless otherwise provided by this Ordinance.


