

ORDINANCE NO. 2859

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF CORSICANA, TEXAS, CLOSING A PORTION OF EAST 9TH AVENUE ACCORDING TO THE OFFICIAL MAP OF CORSICANA, TEXAS.

WHEREAS, the adjacent property owner below has requested that said portions of East 9th Avenue be closed and abandoned; and

WHEREAS, after holding a public hearing it appears that such portions of East 9th Avenue should be closed and abandoned.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CORSICANA, TEXAS:

that the following described property, to-wit:

The full width (called 50 feet) of E. 9th Avenue from the west Right-of-Way line of Naomi Street westerly approximately 100 feet to the northwest corner of Lot 5 in City Block 1453 and the southwest corner of Lot 8 in City Block 1454; as shown on the attached Exhibit A,

be officially closed to the public use, saving and reserving however a utility and drainage easement over, under, and through all of the said East 9th Avenue, and the Mayor is hereby authorized to execute Quit Claim Deeds to adjoining property owners where appropriate.


