AN ORDINANCE ADDING ONE CLASS 1 TOBACCO AND ALTERNATIVE NICOTINE PRODUCTS LICENSE BY AMENDING SECTION 7-8 OF CHAPTER 7 OF THE GURNEE MUNICIPAL CODE ENTITLED "TOBACCO AND ALTERNATIVE NICOTINE RETAILERS"

WHEREAS, the Corporate Authorities of the Village of Gurnee deem it to be in the best interest of the Village to amend the provisions of the Village Code regarding Tobacco and Alternative Nicotine Retailers; and

WHEREAS, the Corporate Authorities of the Village of Gurnee desire to add one Class 1 Tobacco and Alternative Nicotine Products license (incidental sales).

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND THE BOARD OF TRUSTEES OF THE VILLAGE OF GURNEE, LAKE COUNTY, ILLINOIS, IN THE EXERCISE OF ITS HOME RULE POWERS, AS FOLLOWS:

SECTION I: That Section 7-8 of Chapter 7 of the Gurnee Municipal Code, entitled "Number of Licenses, Non-transferability and Records" as last amended by Ordinance No. 2022-09, be and is hereby further amended to add one (1) Class 1 Tobacco and Alternative Nicotine Products license (incidental sales) and shall hereafter state as follows: double underline (insert) denoting inserted language and strikeout (~~delete~~) denoting deleted language):

Sec. 7-8 Numbers of Licenses, Non-transferability and Records

- (a) There shall be no more than 48 19 Class 1 (incidental sales) Tobacco and Alternative Nicotine Products Licenses that may be issued and outstanding at any one time within the Village.
- (b) There shall be no more than 5 Class 2 (primary sales) Tobacco and Alternative Nicotine Products Licenses that may be issued and outstanding at any one time within the Village. In the event that a Class 2 license is lapsed, revoked or a licensed premises becomes vacant for a continuous period of at least 6 months, then the maximum number of Class 2 licenses in the Village shall be automatically reduced by one.
- (c) Licenses are nontransferable.

SECTION II: Nothing in this Ordinance shall be construed to affect any suit or proceedings pending in any court, or any rights acquired, or liability incurred, or any cause or causes of action arising, acquired or existing under any act or ordinance or portion thereof hereby repealed or amended by this ordinance; nor shall any just or legal right, claim, penalty or remedy of any character of the corporate authority existing on the effective date hereof by lost, impaired or affected by this Ordinance.

SECTION III: If any provision, clause, sentence, paragraph, section, or part of this ordinance or application thereof to any person, firm, corporation, public agency or circumstance, shall, for any reason, be adjudged by a court of competent jurisdiction to be unconstitutional or invalid, said judgment shall not affect, impair or invalidate the remainder of this ordinance and the application of such provision to other persons, firms, corporation, or circumstances, but shall be confined in its operation to the provision, clause, sentence, paragraph, section, or part thereof directly involved in the controversy in which such judgment shall have been rendered and to the person, firm, corporation, or circumstances involved. It is hereby declared to be the legislative intent of the corporate authorities that this ordinance would have been adopted had such unconstitutional or invalid provision, clause, sentence, paragraph, section, or part thereof not been included.

SECTION IV: That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.


