



ORDINANCE 2021-23

Amending Chapter 82, Parks and Recreation, of the South Brunswick Township Code Regarding Fees

WHEREAS, the Township of South Brunswick maintains Chapter 82, Parks and Recreation regarding fees charged for Park Facilities; and

WHEREAS, the Department of Parks and Recreation has recommended adjustments to the fees to reflect current costs; and

WHEREAS, it is in the best interest of the Township of South Brunswick to amend the Code to adopt revisions to the fees;

NOW THEREFORE BE IT ORDAINED by the Township Council of the Township of South Brunswick, County of Middlesex, State of New Jersey, that:

I. Sec. 82-9 (i) Fees, of the Township Code of the Township of South Brunswick is hereby repealed in its entirety and replaced with the following:

III. If any clause, sentence, paragraph, section or part of this ordinance or any other codes or ordinances incorporated herein shall be adjudged by any court of competent jurisdiction to be invalid, such judgment shall not affect, impair or invalidate the remainder hereof, but shall be confined in its operation to the clause, sentence, paragraph, section or part thereof directly involved in the controversy in which said judgment shall have been rendered.

IV. This ordinance shall become effective twenty (20) days after its final passage.

The above ordinance was introduced and passed on first reading at a meeting of the Township Council of the Township of South Brunswick held on June 22, 2021. It will be considered on second reading and final passage at a meeting of the Township Council of the Township of South Brunswick to be held either: (1) at the Municipal Building, Monmouth Junction, New Jersey; or, if that is not possible, (2) via video conference, at 6:00 p.m. on July 27, 2021. If

the meeting is held via video conference, an electronic link to the meeting will be made available to the public at www.sbtnj.net no later than noon on the day of the meeting. In either case, at the time of second reading and final passage any person having an interest therein will be given an opportunity to be heard.
