ORDINANCE 2022-10

Amending and Supplementing Chapter 58, Human Relations, Adding a Board of Education Ex Officio Member to the Human Relations Commission (Revised 3/8/2022)

WHEREAS, the Township maintains Chapter 58, Human Relations, specifically Article II, Human Relations Commission, of the South Brunswick Township Code; and

WHEREAS, it has been requested that there be a representative of the South Brunswick Board of Education as an ex-officio member on the Commission; and

WHEREAS, it is in the best interests of the residents of the Township of South Brunswick to amend the Township Code at this time to include such representative;

NOW THEREFORE BE IT ORDAINED, by the Township Council of the Township of South Brunswick, County of Middlesex, State of New Jersey, that:

I. Chapter 58, Human Relations, shall be and is hereby amended and supplemented, with additions in underline and deletions in strikethrough:

Sec. 58-32. - Composition; ex officio members.

- (a) The human relations commission shall consist of nine members, all of whom shall reside or work in the township.
- (b) One ex officio member shall be chosen from among the members of the township council, including the mayor.
- (c) One ex officio member shall be a representative of the South Brunswick Board of Education.
- II. If any clause, sentence, paragraph, section or part of this ordinance or any other codes or ordinances incorporated herein shall be adjudged by any court of competent jurisdiction to be invalid, such judgment shall not affect, impair or invalidate the remainder hereof, but shall be confined in its operation to the clause, sentence, paragraph, section or part thereof directly involved in the controversy in which said judgment shall have been rendered.
- III. This ordinance shall become effective twenty (20) days after its final passage.

The above ordinance was introduced and passed on first reading at a meeting of the Township Council of the Township of South Brunswick held on March 22, 2022. It will be considered on second reading and final passage at a meeting of the Township Council of the Township of South Brunswick to be held either: (1) at the Municipal Building, Monmouth Junction, New Jersey; or, if that is not possible, (2) via video conference, at 6:00 p.m. on April 26, 2022. If the meeting is held via video conference, an electronic link to the meeting will be made available to the public at www.sbtnj.net no later than noon on the day of the meeting. In either case, at the time of second reading and final passage any person having an interest therein will be given an opportunity to be heard.
