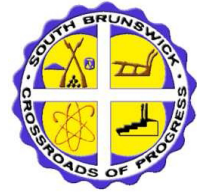

ORDINANCE 2022-21

Amending and Supplementing Chapter 6, Alcoholic Beverages, Increasing the Total Number of Liquor Licenses in South Brunswick

WHEREAS, the Township of South Brunswick maintains Code Chapter 6, Alcoholic Beverages, which, among other things, establishes the total number of Plenary Retail Consumption Licenses and Plenary Retail Distribution Licenses, that can exist in the Township; and

WHEREAS, the total number of licenses that can exist in the Township is established pursuant to N.J.S.A. 33:1-12.14, which indicates that the total number permitted is dependent upon the population in South Brunswick, as determined by the results of the most recent federal decennial census in the Township; and

WHEREAS, based upon the 2020 federal census results, the Township is allowed to add one (1) additional Plenary Retail Consumption License and one (1) additional Plenary Retail Distribution License to the total number of licenses permitted in the Township; and

WHEREAS, the Township Council believes that it is in the best interests of the residents of South Brunswick to increase the total number of Consumption and Distribution licenses at this time;

NOW THEREFORE BE IT ORDAINED by the Township Council of the Township of South Brunswick, County of Middlesex, State of New Jersey, that:

- I. Section 6-42(a) of the Township Code of the Township of South Brunswick shall be and is hereby amended and supplemented as follows, with additions in underline and deletions in strikethrough:

Sec. 6-42. Fees; maximum number.

- (a) The annual license fees and maximum type and number of licenses for the sale and distribution of alcoholic beverages in the township shall be as follows:

Class of License	Annual License Fee	Number of Licenses
Plenary retail consumption license	\$2,400.00 for license year July 1, 2004-June 30, 2005; and \$2,500.00 for each license year thereafter	16-15
Plenary retail distribution license	\$2,400.00 for license year July 1, 2004-June 30, 2005; and \$2,500.00 for each license year thereafter	5-6
Club license	150.00	3

- II. If any clause, sentence, paragraph, section or part of this ordinance or any other codes or

ordinances incorporated herein shall be adjudged by any court of competent jurisdiction to be invalid, such judgment shall not affect, impair or invalidate the remainder hereof, but shall be confined in its operation to the clause, sentence, paragraph, section or part thereof directly involved in the controversy in which said judgment shall have been rendered.

III. This ordinance shall become effective twenty (20) days after its final passage.

The above ordinance was introduced and passed on first reading at a meeting of the Township Council of the Township of South Brunswick held on May 24, 2022. It will be considered on second reading and final passage at a meeting of the Township Council of the Township of South Brunswick to be held either: (1) at the Municipal Building, Monmouth Junction, New Jersey; or, if that is not possible, (2) via video conference, at 6:00 p.m. on June 28, 2022. If the meeting is held via video conference, an electronic link to the meeting will be made available to the public at www.sbtnj.net no later than noon on the day of the meeting. In either case, at the time of second reading and final passage any person having an interest therein will be given an opportunity to be heard.
