



ORDINANCE 2023-5

Amending the South Brunswick Township Code Regarding the Composition of the Economic Development Committee

WHEREAS, the Township of South Brunswick maintains Chapter 2, Administration, Article V, Division 7, Economic Development Committee, of the South Brunswick Township Code; and

WHEREAS, the Township Council recommends changes regarding composition of the committee be incorporated into the Township Code;

NOW THEREFORE BE IT ORDAINED, by the Township Council of the Township of South Brunswick, County of Middlesex, State of New Jersey, that:

I. Sec. 2-542 of the Code of the Township of South Brunswick shall be and is hereby amended as follows, with deletions in strikethrough and additions in underline:

Sec. 2-542. - Composition; qualifications; conflicts of interest; compensation.

(b) Members shall be appointed with special consideration to their qualifications, which shall be based on their experience in the fields of industry, commerce or economics and their commitment to the achievement of the goals and needs of the township in those areas. ~~No more than four regular members shall be from the same political party.~~

II. Sec. 2-545 of the Code of the Township of South Brunswick shall be and is hereby amended as follows, with deletions in strikethrough and additions in underline:

Sec. 2-545. - Officers.

At the first meeting of the year, the economic development committee shall elect, from among its regular members, a chairperson and a vice-chairperson, each of whom shall serve for a one-year term. ~~The chairperson and vice chairperson must be residents of South Brunswick.~~

III. If any clause, sentence, paragraph, section or part of this ordinance or any other codes or ordinances incorporated herein shall be adjudged by any court of competent jurisdiction to be invalid, such judgment shall not affect, impair or invalidate the remainder hereof, but shall be confined in its operation to the clause, sentence, paragraph, section or part thereof directly involved in the controversy in which said judgment shall have been rendered.

IV. This ordinance shall become effective twenty (20) days after its final passage.

The above ordinance was introduced and passed on first reading at a meeting of the Township Council of the Township of South Brunswick held on March 28, 2023. It will be considered on second reading and final passage at a meeting of the Township Council of the Township of South Brunswick to be held either: (1) at the Municipal

Building, Monmouth Junction, New Jersey; or, if that is not possible, (2) via video conference, at 5:00 p.m. on April 25, 2023. If the meeting is held via video conference, an electronic link to the meeting will be made available to the public at www.southbrunswicknj.gov no later than noon on the day of the meeting. In either case, at the time of second reading and final passage any person having an interest therein will be given an opportunity to be heard.
