ORDINANCE 2023-26

**Amending and Supplementing Chapter 110, Traffic, of the South Brunswick Code of the Township of South Brunswick Regarding Gross Vehicle Weight Rating (GVWR)**

WHEREAS, the Township of South Brunswick maintains Chapter 110, Traffic, of the South Brunswick Township Code, specifically Sec. 110-54 regarding Gross Vehicle Weight Rating (GVWR); and

WHEREAS, the South Brunswick Police Department reviewed this section of the Code and believe certain changes need to be made to accurately specify the restrictions that are to be enforced; and

WHEREAS, the Township Council believes that it is in the best interests of the Township of South Brunswick to incorporate these changes into the Township Code at this time;

NOW THEREFORE BE IT ORDAINED by the Township Council of the Township of South Brunswick, County of Middlesex, State of New Jersey, that:

- I. Chapter 110, Traffic, of the Code of the Township of South Brunswick shall be and is hereby amended and supplemented as follows, with additions in underline:

**Sec. 110-54. - Vehicles over designated weight excluded from certain streets.**

Vehicles over the gross vehicle weight rating (GVWR) are hereby excluded from the streets or parts of streets described except for the pick-up and delivery of materials on such streets. GVWR shall include the Registered Gross Vehicle Weight, the value specified by the Manufacturer as the loaded weight of a single or a combination (articulated) vehicle, the GVWR displayed on the vehicle, or the Gross Combination Weight Rating (CGWR), whichever is greatest.

- II. If any clause, sentence, paragraph, section or part of this ordinance or any other codes or ordinances incorporated herein shall be adjudged by any court of competent jurisdiction to be invalid, such judgment shall not affect, impair or invalidate the remainder hereof, but shall be confined in its operation to the clause, sentence, paragraph, section or part thereof directly involved in the controversy in which said judgment shall have been rendered.


- III. This ordinance shall become effective twenty (20) days after its final passage.

The above ordinance was introduced and passed on first reading at a meeting of the Township Council of the Township of South Brunswick held on August 22, 2023. It will be considered on second reading and final passage at a meeting of the Township Council of the Township of South Brunswick to be held either: (1) at the Municipal Building, Monmouth Junction, New Jersey; or, if that is not possible, (2) via video conference, at 6:00 p.m. on September 26, 2023. If the meeting is held via video conference, an electronic link to the meeting will be made available to the public at [www.southbrunswicknj.gov](http://www.southbrunswicknj.gov) no later than noon on the day of the meeting. In either case, at the time of second reading and final passage any person having an interest therein will be given an opportunity to be

heard.
