



ORDINANCE 2023-38

**Amending and Supplementing Chapter 2, Administration,
Article IX, Department of Planning, Zoning and Engineering
Regarding Position of Planning Director**

WHEREAS, Chapter 2, Administration, Article IX of the South Brunswick Code relates to the establishment of the Department of Planning, Zoning and Engineering; and

WHEREAS, the Township Manager has recommended changes be made to the qualifications for the Planning Director;

NOW, THEREFORE BE IT ORDAINED by the Township Council of the Township of South Brunswick, County of Middlesex, State of New Jersey, that;

- I. Chapter 2, Administration, Article IX, Department of Planning, Zoning and Engineering, shall be and is hereby amended and supplemented as follows:

Sec. 2-1032. - Department head; appointment; qualifications.

The head of the department of planning, zoning and engineering shall be the planning director. The planning director shall be appointed by the township manager for an indefinite term of office. The director ~~shall be a NJ licensed Professional Planner,~~ shall hold a master's degree in planning and shall have at least ~~three~~ five years' experience in city or regional planning; or a bachelor's degree in planning or a related field and at least ~~five~~ ten years' experience in city or regional planning.

II. If any clause, sentence, paragraph, section or part of this ordinance or any other codes or ordinances incorporated herein shall be adjudged by any court of competent jurisdiction to be invalid, such judgment shall not affect, impair or invalidate the remainder hereof, but shall be confined in its operation to the clause, sentence, paragraph, section or part thereof directly involved in the controversy in which said judgment shall have been rendered.

III. This ordinance shall become effective twenty (20) days after its final passage.

The above ordinance was introduced and passed on first reading at a meeting of the Township Council of the Township of South Brunswick held on December 12, 2023. It will be considered on second reading and final passage at a meeting of the Township Council of the Township of South Brunswick to be held either: (1) at the Municipal Building, Monmouth Junction, New Jersey; or, if that is not possible, (2) via video conference, at 2:00 p.m. on December 26, 2023. If the meeting is held via video conference, an electronic link to the meeting will be made available to the public at www.southbrunswicknj.gov no later than noon on the day of the meeting. In either case, at the time of second reading and final passage any person having an interest therein will be given an opportunity to be heard.
