ORDINANCE 2018-10

Amending and Supplementing Chapter 110, Traffic and Vehicles, of the Township Code to Prohibit Stopping or Standing and Prohibit Turns at Various Locations Within the Township of South Brunswick

WHEREAS, the South Brunswick Police Department has received a number of parking complaints and concerns in various locations of the Township of South Brunswick; and

WHEREAS, the Traffic Safety Bureau conducted an analysis and has made recommendations to prohibit stopping or standing and prohibiting turns as indicated below;

NOW THEREFORE BE IT ORDAINED, by the Township Council of the Township of South Brunswick, County of Middlesex, State of New Jersey, that:

I. Chapter 110, Traffic and Vehicles, Sec. 110-45, No Stopping or Standing, of the Code of the Township of South Brunswick be amended as follows, with additions in underline and deletions in strikethrough:

Sec. 110-45. - Prohibited Turns

II. Chapter 110, Traffic and Vehicles, Sec. 110-153, No Stopping or Standing, of the Code of the Township of South Brunswick be amended as follows with the addition of the following:

Sec. 110-153. - No stopping or standing.

No person shall stop or stand a vehicle upon any of the following described streets or parts of streets:

- III. The Police Department and Department of Public Works shall ensure that the appropriate signs are installed reflecting this prohibition.
- IV. If any clause, sentence, paragraph, section or part of this ordinance or any other codes or ordinances incorporated herein shall be adjudged by any court of competent jurisdiction to be invalid, such judgment shall not affect, impair or invalidate the remainder hereof, but shall be confined in its operation to the clause, sentence, paragraph, section or part thereof directly involved in the controversy in which said judgment shall have been

rendered.

V. This ordinance shall become effective twenty (20) days after its final passage.

The above ordinance was introduced and passed on first reading at a regular meeting of the Township Council of the Township of South Brunswick held on April 24, 2018 and will be considered on second reading and final passage at a regular meeting of the Township Council of the Township of South Brunswick to be held at the Municipal Building, Monmouth Junction, New Jersey, at 7:30 p.m. on May 22, 2018, at which time and place any person having an interest therein will be given an opportunity to be heard.
