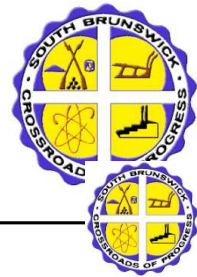

ORDINANCE 2019-32

Amending Chapter 110, Traffic and Vehicles, Regarding No Stopping or Standing on Marc Drive

WHEREAS, at the request of the Dayton Center II homeowners' association, the South Brunswick Police Department conducted an investigation to restrict parking between the driveways of 52 and 54 Marc Drive; and

WHEREAS, it is in the best interests of the Township of South Brunswick to restrict parking on this section of Marc Drive, for the promotion of the health and safety of the public;

NOW THEREFORE BE IT ORDAINED by the Township Council of the Township of South Brunswick, County of Middlesex, State of New Jersey, that:

- I. Chapter 110, Traffic and Vehicles, of the South Brunswick Township Code is hereby amended as follows, with the addition of the following:

Sec. 110-153. - No stopping or standing.

No person shall stop or stand a vehicle upon any of the following described streets or parts of streets:

Name of Street	Side	Location
<u>Marc Drive</u>	<u>North</u>	<u>Starting from a point 680 feet from the northern curb line of Ridge Road's west most intersection with Marc Drive, proceeding east for a total of 56 feet</u>

- II. The Township shall install all appropriate measures to advise motorists of the parking restriction, and shall install and maintain any such measures that are installed in compliance with the Manual on Uniform Traffic Control Devices.
- III. If any clause, sentence, paragraph, section or part of this ordinance or any other codes or ordinances incorporated herein shall be adjudged by any court of competent jurisdiction to be invalid, such judgment shall not affect, impair or invalidate the remainder hereof, but shall be confined in its operation to the clause, sentence, paragraph, section or part thereof directly involved in the controversy in which said judgment shall have been rendered.
- V. This ordinance shall become effective twenty (20) days after its final passage and, as to the weight restrictions, upon approval by the New Jersey Department of Transportation.

The above ordinance was introduced and passed on first reading at a meeting of the

Township Council of the Township of South Brunswick held on September 24, 2019, and will be considered on second and final reading and final passage at a meeting of the Township Council of the Township of South Brunswick to be held at the Municipal Building, Monmouth Junction, New Jersey, at 6:00 p.m. on, October 22, 2019, at which time and place any person having an interest therein will be given an opportunity to be heard.
