AN ORDINANCE AMENDING CHAPTER 78, ARTICLE V, DIVISION 5, SECTION 78-316(H)(3)(A) MS-EMS-2 PERMITTED USES AND CHAPTER 78, ARTICLE 1, SECTION 78-2, DEFINITIONS OF THE CODE OF THE CITY OF ANOKA MINNESOTA

THE COUNCIL OF THE CITY OF ANOKA ORDAINS:

- Section 1. Pursuant to Minnesota Law, the Anoka City Charter and the Anoka City Code, and upon a review conducted by City staff, Chapter 78, Article V, Division 5, Section 78-316(h)(3)(a) MS ESM-2 Permitted Uses and Chapter 78, Article 1, Section 78-2, Definitions is hereby adopted, by an affirmative vote of a majority of the Anoka City Councilmembers present, to read with stricken text deleted and underlined, italicized text inserted into existing code as shown on Exhibit A.
- Section 2. This Ordinance shall be in full force and effective upon passage and seven (7) days after publication.

CHAPTER 78 ZONING

Article I.

Sec. 78-2. - Definitions.

The following words, terms and phrases, when used in this chapter, shall have the meanings ascribed to them in this section, except where the context clearly indicates a different meaning. Similar words or phrases defined in particular sections shall have the meanings ascribed to them for that particular section.

Vet (Veterans) Center means a United States Federal Government community-based counseling center facility run by the Department of Veteran Affairs within the Veterans Health Administration Readjustment Counseling Service or RCS that provides a wide range of social and psychological services, including professional readjustment counseling to eligible Veterans, active duty service members, including members of the National Guard and Reserve components, and their families. This does not include transitional housing or homeless shelter services.

Article V. Division 5.

Sec. 78-316. - Main Street Mixed-use District (MS).

(h) *Permitted, conditional, interim, accessory and prohibited uses.*

(3) *East Main Street Subdistrict 2 (EM-2).*

- a. *Permitted uses.* The following uses are permitted in the East Main Street Subdistrict 2 (EM-2):
 1. All permitted uses listed in the East Main Street Subdistrict 1 (EM-1);
 2. Medical or dental laboratories;
 3. Mortuaries, funeral homes and chapels;
 4. Vet (Veterans) Center.
