

**AN ORDINANCE FIXING SALARIES  
OF THE MEMBERS AND OFFICERS OF THE  
FLOYD COUNTY BOARD OF SUPERVISORS**

**WHEREAS**, Section 15.2-1414.3 of the *Code of Virginia*, 1950, as amended, authorizes the boards of supervisors of the several counties in Virginia to establish the salaries of the members of such boards by ordinance following notice and a public hearing on the same; and

**WHEREAS**, the Board of Supervisors of Floyd County, Virginia (the "Board"), held a public hearing on June \_\_\_\_, 2019, following due notice thereof as required by law on the salaries of the members of the Board; and

**WHEREAS**, the Board has determined that it is in the best interests of the County to set the salaries of the members of the Board by ordinance and desires to provide therefor;

**NOW, THEREFORE, BE IT ORDAINED** by the Board of Supervisors of Floyd County, Virginia, that the following ordinance to be known as "An Ordinance Fixing Salaries of the Members and Officers of the Board of Supervisors" is hereby adopted and ordained as follows:

**Board Member and Board Officer Salaries**

1. Pursuant to Virginia Code § 15.2-1414.3, the annual salary of each member of the Board of Supervisors of the County of Floyd is hereby established at Five Thousand, Five Hundred Dollars (\$5,500), commencing on July 1, 2019. An additional salary in the amount of One Thousand, Eight Hundred Dollars (\$1,800) shall be paid to the Chair of the Board, and an additional salary in the amount of One Thousand, Two Hundred Dollars (\$1,200) shall be paid to the Vice-Chair of the Board.
2. The annual salaries established and fixed herein shall be paid in equal monthly installments.
3. Nothing herein shall be deemed to repeal or prohibit the provision of such fringe benefits as may be available to or provided to the Board in accordance with applicable law, including without limitation insurance or other benefits provided generally to County employees.
4. This ordinance and the salaries established herein shall remain in effect henceforth and from year to year until changed by amendment to this ordinance.

This ordinance shall become effective July 1, 2019.
