

ORDINANCE O2019-05

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF WEATHERFORD, TEXAS, AMENDING WEATHERFORD CODE OF ORDINANCES, TITLE X MOTOR VEHICLES AND TRAFFIC, CHAPTER 3 TRAFFIC-CONTROL DEVICES, SECTION 10-3-12 SPECIFICALLY CONTROLLED STREETS BY ADDING THERETO CERTAIN INTERSECTIONS FOR THE ENFORCEMENT OF TRAFFIC CONTROL DEVICES ON RIGHT-OF-WAYS IN THE CITY OF WEATHERFORD, TEXAS, PROVIDING FOR THE REPEAL OF ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT, AND PROVIDING A SAVINGS CLAUSE, ESTABLISHING A PENALTY

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WEATHERFORD, TEXAS

SECTION 1 That the Weatherford Code of Ordinances, Title X Motor Vehicles and Traffic, Chapter 3 Traffic-Control Devices, Section 10-3-12 Specifically Controlled Streets be amended by adding the following intersections, ALPHABETICALLY, to-wit

SECTION 2: That the traffic control signs, signals, devices and markings placed or erected by the Police Department or the Street Department for the purpose of regulating, warning or guiding traffic are hereby declared to be official traffic control devices at the above intersection.

SECTION 3: Any person who drives or operates any vehicle in violation of the traffic control signs, signals, devices and markings on rights-of-way in the City of Weatherford shall be guilty of a misdemeanor and upon conviction therefore, shall be fined in an amount not to exceed \$200.00


SECTION 4: All ordinances and parts of ordinances in conflict with this ordinance shall be and the same are hereby repealed to the extent of said conflict only.

SECTION 5: If any section, subsection, paragraph, sentence, clause, phrase or word of this ordinance or the application thereof to any person or circumstance is held invalid or unconstitutional, ordinance or the application thereof to any person or circumstance is held invalid or unconstitutional, such holding shall not affect the validity of the remaining portions of this ordinance, and the City Council hereby declares that it would have passed such remaining portions despite such invalidity or unconstitutionality and it is accordingly so ordained.


The foregoing ordinance was introduced, read, and passed by a vote of 5 ayes and 0 nays at a meeting of the City Council of the City of Weatherford, Texas, at its meeting held on the 12th day of February, 2019.
