ORDINANCE NO. 765

AN ORDINANCE TO AMEND THE SAGINAW TOWNSHIP ZONING ORDINANCE,
ZONING MAP, (ORDINANCE #423 BEING SECTION 602
OF THE SAGINAW CHARTER TOWNSHIP CODE OF ORDINANCES),
SAGINAW COUNTY, MICHIGAN

The Charter Township of Saginaw, Saginaw County, Michigan

ORDAINS:

The Saginaw Township Zoning Ordinance, Saginaw Township, Saginaw County, Michigan be and hereby is amended as follows:

Proposed Amendment

1. That sub-paragraph 10 (Parking of Recreational Vehicles and Equipment) of Section 302, Chapter 3 General Requirements, Part I General Provisions of the Saginaw Charter Township Zoning Ordinance (Appendix A of the Saginaw Charter Township Code of Ordinances) is amended to read as follows:

302(10) Parking of Recreational Vehicles and Equipment

The parking of recreational vehicles and equipment, including travel trailers, campers, boats and similar recreational equipment, is prohibited within the required yard areas of any "R" district, except recreational, vehicles and equipment are permitted for periods of not to exceed five consecutive days, whereupon said vehicle shall be completely removed from the property for a minimum of eight hours. The vehicle and/or equipment shall be parked on a dust-free, weed-free surface constructed of asphalt, concrete, **crushed gravel or paver stones and covering at minimum the entire footprint of the parked equipment. Crushed gravel parking areas must be constructed of a sand or gravel base with weed barrier, and at least four (4) inches depth of crushed stone, and feature a defined edge unless otherwise approved by the zoning administrator or building inspector.**

Section 2. Conflict and Repeal. All ordinances or parts of ordinances in conflict with this Ordinance are repealed.

Section 3. Effective Date. The adoption of this Ordinance is hereby declared an emergency effecting the public peace, health and safety and this Ordinance shall, therefore, be effective (immediately upon its adoption).

Section 4. Publication. After its adoption, this Ordinance or a summary thereof, as permitted by law, shall be published by the Township Clerk in the Township View, a newspaper of general circulation in Saginaw Charter Township.

The foregoing shall be published in the Township View, a newspaper of general circulation in the Charter Township of Saginaw, on the 27th day of February, 2020.

This Ordinance shall take effect upon the date of publication.
