

**LICENSE AND PERMIT FEES AND RATES
FOR THE 2009 LICENSING YEAR
CITY OF MACKINAC ISLAND, MICHIGAN
Ordinance No. 437, effective May 1, 2009**

An ordinance to set and establish those fees and rates for license and rates for licenses, permits and other municipal services of which are provided for and required through the enactment of various regulatory ordinances or resolutions.

THE CITY OF MACKINAC ISLAND ORDAINS:

Sec. 1 PURPOSE OF FEES AND RATES

For the enhancement of public safety, public service and general welfare, the use of the municipal and public properties and personnel are made available to and are utilized by individuals, or groups of individuals, for the common good in order to ensure that such use and activity is in the best interest of the public. Such provision of services does result in financial obligations upon the City of which are more appropriately assessed upon the user of such service. Those fees and rates herein established and ordained are intended to be reasonable in their assessment in order to recover a portion of cost incurred by the City of Mackinac Island in the provision of these services.
