On the motion of Commissioner Brunson, which carried unanimously, the following Ordinance amendment was adopted:

AN AMENDMENT TO THE CODE OF ORDINANCES OF GLYNN COUNTY, GEORGIA, TO REVISE SECTION 2-4-2 OF THE ANIMAL CONTROL ORDINANCE OF GLYNN COUNTY TO ADD A NEW NAME FOR THE ANIMAL CONTROL UNIT; AND FOR OTHER PURPOSES.

BE IT ORDAINED, by the Glynn County Board of Commissioners, this 19th day of August, 2021, that Section 2-4-2 of the Code of Ordinances, Glynn County, Georgia, be and is hereby amended as follows:

SECTION I.

Section 2-4-2 of the Animal Control Ordinance of Glynn County is hereby amended to add a sentence establishing an alternate name for the Animal Control Unit. The amended ordinance shall read as follows:

2-4-2 **Animal Control Unit.** There is hereby created an Animal Control Unit for Glynn County under the general supervision of the Board of Commissioners of Glynn County. The Animal Control Unit shall also be referred to and known as "Glynn County Animal Services".
