On the motion of O'Quinn, which carried unanimously, the following Ordinance was adopted:

**AN AMENDMENT TO THE GLYNN COUNTY CODE OF ORDINANCES,  
GLYNN COUNTY, GEORGIA, TO AMEND SECTIONS 2-2-25 OF THE  
EMERGENCY MANAGEMENT ORDINANCE TO DESIGNATE POSITION  
HOLDERS AND CLARIFY ORGANIZATIONAL STRUCTURE.**

**BE IT ORDAINED**, by the Glynn County Board of Commissioners, this 6th day of October, 2022, that Sections 2-2-25 of the Code of Ordinances, Glynn County, Georgia is hereby amended as follows:

**SECTION I: Section 2-2-25 (b) is hereby amended to read as follows:**

**2-2-25            Organization.**

(b) The Board of Commissioners of Glynn County shall nominate a director of emergency management and homeland security who shall be appointed in accordance with the provisions of O.C.G.A. § 38-3-27. The director shall be subject to the direction and control of the Board of Commissioners, through the Glynn County Manager, and shall be responsible for the carrying out of the programs for emergency management in Glynn County. The Glynn County Deputy Director of Emergency Management and Homeland Security shall act as the acting director of emergency management and homeland security in the event of the absence or disability of the director for any reason. The compensation of the director shall be fixed by the Board of Commissioners and the director shall hold the office at the pleasure of the Board of Commissioners.

**SECTION II: Section 2-2-25 (e) is hereby amended to read as follows:**

**2-2-25            Organization.**

(e) The County Manager and Assistant County Manager shall coordinate as incident commanders and shall act for the Chairman of the Board of Commissioners when requested to do so by the Chairman of the Board of Commissioners or the Vice-Chairman in the Chairman's absence.

**This Amendment** shall become effective immediately upon adoption.

### **2-2-25            Organization.**

(b) The Board of Commissioners of Glynn County shall nominate a director of emergency management and homeland security who shall be appointed in accordance with the provisions of O.C.G.A. § 38-3-27.
