A BILL TO BE ENTITLED
AN ACT

1 To amend an Act creating the board of commissioners of Brantley County, approved
2 July 21, 1927 (Ga. L. 1927, p. 500), as amended, so as to authorize the chairperson of the
3 board of commissioners to make and second motions and vote on all matters that come
4 before the board for a vote; to provide for related matters; to repeal conflicting laws; and for
5 other purposes.

6 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

7 **SECTION 1.**

8 An Act creating the board of commissioners of Brantley County, approved July 21, 1927
9 (Ga. L. 1927, p. 500), as amended, is amended by adding a new section to read as follows:

10 "SECTION 4.1.

11 Notwithstanding anything to the contrary, the chairperson of the board of commissioners
12 shall be authorized to make and second motions and vote on all matters that come before
13 the board for a vote."

SECTION 2.

15 All laws and parts of laws in conflict with this Act are repealed.
