

**ORDINANCE 22-34**  
**TO AMEND THE OCCUPATION TAX SECTION OF THE COUNTY OF BALDWIN**  
**CODE OF ORDINANCES TO MODIFY THE TAX SCHEDULE.**

WHEREAS, the Board of Commissioners of Baldwin County, Georgia is desirous of amending Chapter 22, "Occupation Tax," of the Baldwin County Code of Ordinances to amend a provision specifying the business occupation tax levied; and

NOW THEREFORE BE IT ORDAINED by the Board of Commissioners of Baldwin County, meeting in formal session, that the Occupation Tax Schedule Section of the Baldwin County Code of Ordinances be amended so that Section 22-34 (b) relating to the business occupation tax schedule read as follows:

(b) Occupation Tax Schedule.

Number of Employees	Tax Rate
1-3	\$50.00
4-9	\$100.00
10-19	\$200.00
20-29	\$350.00
30-39	\$500.00
40-49	\$600.00
50 or more	\$1,000.00

This occupation tax schedule shall be effective for calendar year 2017.

NOW THEREFORE BE IT FURTHER ORDAINED by the Board of Commissioners of Baldwin County, meeting in formal session, that the Occupation Tax Schedule Section of the Baldwin County Code of Ordinances be amended so that Section 22-34 (b) relating to the business occupation tax schedule read as follows:

(b) Occupation Tax Schedule.

Number of Employees	Tax Rate
1-3	\$100.00
4-9	\$200.00
10-19	\$350.00
20-29	\$500.00
30-39	\$800.00
40-49	\$1,000.00
50 or more	\$1,500.00


This occupation tax schedule shall be effective for calendar years 2018 and subsequent years unless further amended.
