

ORDINANCE NO. 4178

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AMENDING SECTION 58-122 OF THE POMONA CITY CODE PERTAINING TO SPEED LIMITS ON DESIGNATED CITY STREETS

BE IT ORDAINED, by the City Council of the City of Pomona as follows:

SECTION 1. That Pomona City Code Section 58-122, is hereby amended by adjusting the speed limits for those City streets, or portions thereof, listed below:
